- 2 MADE BY THE COUNTY BOARD OF EACH REGIONAL COUNTY FROM COUNTY, STATE,
- 3 AND FEDERAL APPROPRIATIONS FOR PUBLIC ELEMENTARY AND SECONDARY
- 4 EDUCATION IN THE PRIOR FISCAL YEAR DIVIDED BY THE FULL-TIME EQUIVALENT
- 5 ENROLLMENT OF THE REGIONAL COUNTY IN THE PRIOR FISCAL YEAR.
