AN ACT concerning
Health Insurance – Provider Panels – <del>Registered Psychology Associates</del> <u>Providers of Community–Based Health Services</u>
FOR the purpose of prohibiting a carrier from rejecting a provider who provides community—based health services for an accredited program solely because the provider <u>practices within the scope of the provider's license and</u> is a registered psychology associate; <u>altering the reason for which a carrier is prohibited from rejecting a certain provider for participation on the carrier's provider panel;</u> making a stylistic change; and generally relating to health insurance and provider panels.

10 11	(g) (1) A provider that seeks to participate on a provider panel of a carrier shall submit an application to the carrier.
12 13 14	(2) (i) Subject to subparagraph (ii) of this paragraph and paragraph (3) of this subsection, the carrier, after reviewing the application, shall accept or reject the provider for participation on the carrier's provider panel.
15 16 17 18	(ii) A carrier may not reject a provider who provides community—based health services for a program accredited under COMAR 10.63.02 for participation on the carrier's provider panel solely because the provider <u>PRACTICES</u> <u>WITHIN THE SCOPE OF THE PROVIDER'S LICENSE AND</u> is:
