- 1 (a) (1) In this section the following words have the meanings indicated. 2 **(4)** "Individualized education program" and "individualized family service plan" have the same meaning as provided in the federal Individuals with Disabilities 3 Education Act. 4 5 When a team of qualified professionals and the parents meet for the (b) (1)6 purpose of discussing the identification, evaluation, educational program, or the provision 7 of a free appropriate public education of a child with a disability: 8 (i) The parents of the child shall be afforded the opportunity to 9 participate and shall be provided reasonable notice in advance of the meeting; and 10 (ii) Reasonable notice shall be at least 10 calendar days in advance of the meeting, unless an expedited meeting is being conducted to: 11 121. Address disciplinary issues; 13 2. Determine the placement of the child with a disability not currently receiving educational services; or 14 15 3. Meet other urgent needs of a child with a disability to 16 ensure the provision of a free appropriate public education. 17 1. At the initial evaluation meeting, the parents of the child (i) 18 shall be provided: 19 A. In plain language, an oral and written explanation of the 20 parents' rights and responsibilities in the individualized education program process and a 21program procedural safeguards notice; and 22 В. Written information that the parents may use to contact 23early intervention and special education family support services staff members within the 24local school system and a brief description of the services provided by the staff members. 25If a parent's native language is not English, the 26 information in subsubparagraph 1B of this subparagraph shall be provided to the parent 27 in the parent's native language. 28 The parents may request the information provided under 29subparagraph (i) of this paragraph at any subsequent meeting.
 - (iii) If a child who has an individualized education program developed in another school system moves into a different local school system, that local school system shall provide the information required under subparagraph (i)1B of this paragraph at the time of the first written communication with the parents regarding the

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 16 1, 2019.
