11 12	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

15 16 17 18	(a) Except as provided in subsections (b) and (c) of this section and § 9–1A–26(a)(3) of this subtitle, on a properly approved transmittal prepared by the Commission, the Comptroller shall pay the following amounts from the proceeds of video lottery terminals at each video lottery facility:

- 9 (c) (1) For the first 10 years of operations at a video lottery facility in Allegany 10 County, on a properly approved transmittal prepared by the Commission, the Comptroller 11 shall pay the following amounts from the proceeds of video lottery terminals at a video 12 lottery facility in Allegany County:
