A BILL ENTITLED

1 AN ACT concerning

Criminal Law - Tobacco Products - Minimum Age

3 FOR the purpose of altering the age requirements for certain provisions of law relating to 4 tobacco products; prohibiting a person from selling or dispensing tobacco products 5 through a vending machine unless the machine is located in an establishment that 6 an individual under a certain age is prohibited by law from entering; prohibiting the 7 distribution of a tobacco product or tobacco paraphernalia to an individual under a 8 certain age except under certain circumstances; prohibiting an individual under a 9 certain age from using or possessing a tobacco product or cigarette rolling paper or from obtaining or attempting to obtain a tobacco product or cigarette rolling paper 10 11 using false identification; prohibiting the distribution of a certain electronic nicotine 12 delivery device or a certain product used to refill or resupply a certain electronic 13 device to an individual under a certain age; altering a certain provision relating to 14 budget appropriations by the Governor aimed at reducing tobacco use; altering a 15 certain purpose of the Cigarette Restitution Fund; making conforming changes; and 16 generally relating to the minimum age for the purchase of tobacco products.

 (2) A person who distributes tobacco products for commercial purposes, including a person licensed under Title 16 of the Business Regulation Article, may not distribute to [a minor] AN INDIVIDUAL UNDER THE AGE OF 21 YEARS:
- 6 (i) a tobacco product;
- 7 (ii) tobacco paraphernalia; or
- 8 (iii) a coupon redeemable for a tobacco product.
- 9 (c) A person not described in subsection (b)(2) of this section may not:
- 10 (1) purchase for or sell a tobacco product to [a minor] AN INDIVIDUAL 11 UNDER THE AGE OF 21 YEARS; or
- 12 (2) distribute tobacco paraphernalia to [a minor] AN INDIVIDUAL UNDER 13 THE AGE OF 21 YEARS.
- 14 (d) In a prosecution for a violation of this section, it is a defense that the defendant 15 examined the purchaser's or recipient's driver's license or other valid identification issued 16 by an employer, government unit, or institution of higher education that positively 17 identified the purchaser or recipient as at least [18] 21 years of age.
- 18 (e) A person who violates this section is guilty of a misdemeanor and on conviction 19 is subject to a fine not exceeding:
- 20 (1) \$300 for a first violation;
- 21 (2) \$1,000 for a second violation occurring within 2 years after the first 22 violation; and
- 23 (3) \$3,000 for each subsequent violation occurring within 2 years after the 24 preceding violation.
- 25 (f) For purposes of this section, each separate incident at a different time and 26 occasion is a violation.



- 1 This section does not apply to the possession of a tobacco product or cigarette 2 rolling paper by [a minor] AN INDIVIDUAL UNDER THE AGE OF 21 YEARS who is acting 3 as the agent of the [minor's] INDIVIDUAL'S employer within the scope of employment. 4 (c) [A minor] AN INDIVIDUAL UNDER THE AGE OF 21 YEARS may not: use or possess a tobacco product or cigarette rolling paper; or 5 (1) 6 obtain or attempt to obtain a tobacco product or cigarette rolling paper (2)7 by using a form of identification that: 8 (i) is falsified; or 9 (ii) identifies an individual other than the [minor] INDIVIDUAL 10 USING THE IDENTIFICATION. - 1 (1) (b) The Fund is a continuing, nonlapsing fund that is not subject to § 2 7–302 of this subtitle. 3 There shall be credited to the Fund all revenues consisting of funds 4 received by the State from any source resulting, directly or indirectly, from any judgment against or settlement with tobacco product manufacturers, tobacco research associations, 5 6 or any other person in the tobacco industry relating to litigation, administrative 7 proceedings, or any other claims made or prosecuted by the State to recover damages for 8 violations of State law. 9 There shall be credited to the Fund all money collected under § 24–508 10 of the Health – General Article or § 5–608 of the Labor and Employment Article. 11 (c) The Treasurer shall: 12 (1) invest and reinvest the Fund in the same manner as other State funds; 13 and 14 (2)credit any investment earnings to the Fund. 15 Expenditures from the Fund shall be made by an appropriation in the annual (d) State budget. 16 17 The Fund shall be expended subject to any restrictions on its use or other limitations on its allocation that are: 18 19 expressly provided by statute; (i) 20required as a condition of the acceptance of funds; or (ii) 21(iii) determined to be necessary to avoid recoupment by the federal 22government of money paid to the Fund. 23(2)Disbursements from the Fund to programs funded by the State or with federal funds administered by the State shall be used solely to supplement, and not to 2425supplant, funds otherwise available for the programs under federal or State law as provided 26 in this section. 27 (f) The Cigarette Restitution Fund shall be used to fund: (1) 28 the Tobacco Use Prevention and Cessation Program established under Title 13, Subtitle 10 of the Health – General Article; 2930 (ii) the Cancer Prevention, Education, Screening, and Treatment

26 27 28	(2) The Governor shall include in the annual budget bill appropriations from the Fund equivalent to the lesser of \$100,000,000 or 90% of the funds estimated to be available to the Fund in the fiscal year for which the appropriations are made.
29 30 31	(3) For each fiscal year for which appropriations are made, at least 50% of the appropriations shall be made for those purposes enumerated in subsection (f)(1)(i), (ii), and (iii)1 through 9 of this section subject to the requirement of subsection (e)(2) of this

- 1 (4) For each fiscal year for which appropriations are made, at least 30% of the appropriations shall be made for the purposes of the Maryland Medical Assistance Program.
- 4 (5) For each fiscal year for which appropriations are made, 0.15% of the 5 Fund shall be appropriated for the purposes of enforcement of Title 16, Subtitle 5 of the 6 Business Regulation Article.
- 7 (6) Any additional appropriations, not subject to paragraph (3), paragraph 8 (4), or paragraph (5) of this subsection, may be made for any lawful purpose.
- 9 (h) For each program, project or activity receiving funds appropriated under 10 subsection (g)(3) of this section, the Governor shall:
- 11 (1) develop appropriate statements of vision, mission, key goals, key 12 objectives, and key performance indicators and report these statements in a discrete part 13 of the State budget submission, which shall also provide data for key performance 14 indicators; and
- 15 (2) report annually, subject to § 2–1246 of the State Government Article, to the General Assembly no later than November 1 on:
- 17 (i) total funds expended, by program and subdivision, in the prior 18 fiscal year from the Fund established under this section; and
- 19 (ii) the specific outcomes or public benefits resulting from that 20 expenditure.
