Task Force to Study Redistricting in Maryland

FOR the purpose of establishing a Task Force to Study Redistricting in Maryland; specifying the composition, powers, and duties of the Task Force; providing for the staffing of the Task Force; requiring the Task Force to report its findings and recommendations, including suggested constitutional and legislative changes, to the Governor and to the General Assembly by a certain date; providing for the termination of this Act; and generally relating to the Task Force to Study Redistricting in Maryland.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That:

- 12 (a) There is a Task Force to Study Redistricting in Maryland.
- 13 (b) The Task Force shall consist of the following thirteen members:
- 14 (1) Two members of the Senate of Maryland, one of whom shall be a 15 member of the minority party of the Senate, appointed by the President of the Senate;
- 16 (2) Two members of the House of Delegates, one of whom shall be a 17 member of the minority party of the House, appointed by the Speaker of the House; 18 and
- 19 (3) Twelve individuals appointed by the Governor to reflect the ethnic,20 racial, gender, and geographic diversity of the State, including:
- 21 (i) A representative of the League of Women Voters of 22 Maryland;

1 (3) As it considers appropriate, receive testimony from and consult 2 with individuals who are knowledgeable about State and federal constitutional and 3 statutory requirements and other matters related to the redistricting process; and

4 (4) Suggest any constitutional or statutory changes that it concludes 5 are desirable in order to improve the redistricting process in Maryland to ensure that, 6 to the greatest extent practicable, General Assembly and congressional districts are 7 compact, contiguous, respectful of the State's natural boundaries, and promote full and 8 vigorous participation in the political process by the citizens of the State.

9 (f) On or before December 31, 2013, the Task Force shall report its findings 10 and recommendations, including any proposed changes to the Maryland Constitution 11 or any statutory changes to the Maryland election law, to the Governor and, subject to 12 § 2–1246 of the State Government Article, the General Assembly for consideration by 13 the General Assembly in the 2014 Session.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 15 July 1, 2012. It shall remain effective for a period of 2 years and, at the end of June 30, 16 2014, with no further action required by the General Assembly, this Act shall be 17 abrogated and of no further force and effect.
