## A BILL ENTITLED

1 AN ACT concerning

2 **Commercial Law – Consumer Protection – Ticket Transfers, Sales, and Resales**

3 FOR the purpose of prohibiting a ticket seller or an operator of a ticket seller’s Web site  
4 from prohibiting the transfer of a certain ticket, requiring an additional fee for the  
5 transfer of a certain ticket, or requiring a purchaser of a ticket to present certain  
6 identification or a certain credit card to gain entry to an entertainment event; and  
7 generally relating to the purchase and transfer of tickets.

8 BY repealing and reenacting, without amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Commercial Law**

22 (a) In this subtitle the following words have the meanings indicated.

23 (b) (1) “Entertainment event” means:

- 1 (i) A performance;
- 2 (ii) A recreation;
- 3 (iii) An amusement;
- 4 (iv) A diversion;
- 5 (v) A spectacle;
- 6 (vi) A show; or
- 7 (vii) Any similar event.

8 (2) "Entertainment event" includes:

- 9 (i) A theatrical or musical performance;
- 10 (ii) A concert;
- 11 (iii) A film;
- 12 (iv) A game;
- 13 (v) A ride; and
- 14 (vi) A sporting event.

15 (c) "Ticket" means a ticket for admission to an entertainment event.

17 **A TICKET SELLER OR AN OPERATOR OF A TICKET SELLER'S WEB SITE MAY**  
18 **NOT:**

19 **(1) PROHIBIT THE TRANSFER OF A TICKET BY THE PURCHASER TO**  
20 **ANOTHER PERSON;**

21 **(2) REQUIRE AN ADDITIONAL FEE FOR THE TRANSFER OF A TICKET**  
22 **BY THE PURCHASER TO ANOTHER PERSON; OR**

23 **(3) REQUIRE THE PURCHASER OF A TICKET TO PRESENT TO GAIN**  
24 **ENTRY TO THE ENTERTAINMENT EVENT:**

25 **(I) A PHOTO IDENTIFICATION OF THE PURCHASER; OR**

1                                   **(II) THE CREDIT CARD ORIGINALLY USED TO PURCHASE THE**  
2 **TICKET.**

3                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
4 October 1, 2016.
