## A BILL ENTITLED

1 AN ACT concerning

2 **Corporations and Real Estate Investment Trusts – Miscellaneous Provisions**

3 FOR the purpose of providing that a Maryland corporation or a real estate investment  
4 trust has the power to renounce certain business opportunities in certain  
5 documents or by certain resolutions; repealing certain provisions of law  
6 prohibiting the declaration or payment of a dividend payable in shares of one  
7 class of a corporation's stock to holders of shares of another class of the  
8 corporation's stock unless approved in a certain manner; altering the  
9 circumstances under which a corporation registered as an open-end company  
10 may redeem shares of its stock from any stockholder; requiring each nominee  
11 for director of a corporation to have the qualifications required by the charter or  
12 bylaws of the corporation; providing that a director of a corporation holds office  
13 until the time the director ceases to have certain qualifications under certain  
14 circumstances; specifying how the directors who hold over and continue to serve  
15 as directors must be determined under certain circumstances; clarifying the  
16 circumstances under which certain actions may be taken without a meeting of  
17 the board of directors or a committee of the board; clarifying that certain  
18 references to a majority or other proportion of directors refer to a majority or  
19 other proportion of votes entitled to be cast by the directors; establishing a  
20 certain limitation on a board's sole power to take certain actions relating to  
21 special meetings of stockholders; providing that a certain interest with which a  
22 proxy may be coupled includes an interest as a party to a certain voting  
23 agreement; authorizing two or more stockholders to enter into a written  
24 agreement requiring voting rights to be exercised in a certain manner under  
25 certain circumstances; altering the circumstances under which the approval of  
26 the stockholders and articles of transfer or share exchange are not required;  
27 altering the manner in which a certain merger of a Maryland corporation or  
28 Maryland real estate investment trust must be approved; establishing that a  
29 merger of a subject corporation with or into an acquiring entity may be effected  
30 under certain circumstances; requiring the board of directors of a certain  
31 Maryland corporation to adopt a certain resolution approving a certain merger

2 approve a certain transaction in a certain manner under certain circumstances;  
3 requiring a certain acquiring entity to give a certain notice of a certain  
4 transaction to certain stockholders of record under certain circumstances;  
5 providing that a minority stockholder of a subject corporation has a right to  
6 demand and receive certain payment of shares under certain circumstances;  
7 altering the information that must be included in articles of consolidation,  
8 merger, share exchange, or transfer under certain circumstances; providing that  
9 certain information included in articles of consolidation, merger, share  
10 exchange, or transfer may be made dependent on facts ascertainable outside the  
11 articles; altering the basis for determining when fair value of the stock of a  
12 Maryland corporation is determined; altering the circumstances in which a  
13 certain stockholder is authorized to demand fair value of the stockholder's stock;  
14 altering the circumstances in which a certain stockholder must file a certain  
15 written objection to a certain transaction; repealing certain provisions of law  
16 requiring the president or director of a certain corporation, the charter of which  
17 has been revived, to call a meeting of the stockholders for a certain purpose;  
18 altering the manner in which an other entity converting to a certain Maryland  
19 corporation or a real estate investment trust must execute articles of  
20 incorporation or a declaration of trust; providing that a real estate investment  
21 trust is a separate legal entity; providing that a real estate investment trust is  
22 formed by filing a declaration of trust for record with the State Department of  
23 Assessments and Taxation; defining certain terms; making certain conforming  
24 and stylistic changes; and generally relating to corporations and real estate  
25 investment trusts.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Corporations and Associations**

4 2–103.

5 Unless otherwise provided by law or its charter, a Maryland corporation has the  
6 general powers, whether or not they are set forth in its charter, to:

7 (1) Have perpetual existence, although existence may be limited to a  
8 specified period if the limitation is stated in a charter provision adopted after May 31,  
9 1908;

10 (2) Sue, be sued, complain, and defend in all courts;

11 (3) Have, use, alter, or abandon a corporate seal;

12 (4) Transact its business, carry on its operations, and exercise the  
13 powers granted by this article in any state, territory, district, and possession of the  
14 United States and in any foreign country;

15 (5) Make contracts and guarantees, incur liabilities, and borrow  
16 money;

17 (6) Sell, lease, exchange, transfer, convey, mortgage, pledge, and  
18 otherwise dispose of any or all of its assets;

19 (7) Issue bonds, notes, and other obligations and secure them by  
20 mortgage or deed of trust of any or all of its assets;

21 (8) Acquire by purchase or in any other manner, and take, receive,  
22 own, hold, use, employ, improve, and otherwise deal with any interest in real or  
23 personal property, wherever located;

24 (9) Purchase, take, receive, subscribe for, or otherwise acquire, own,  
25 hold, vote, use, employ, sell, mortgage, loan, pledge, or otherwise dispose of and  
26 otherwise use and deal in and with stock and other interests in and obligations of  
27 other Maryland and foreign corporations, associations, partnerships, and individuals;

28 (10) Subject to the limitations provided in this article, acquire any of its  
29 own stock, bonds, notes, and other obligations and securities;

30 (11) Invest its surplus funds, lend money from time to time in any  
31 manner which may be appropriate to enable it to carry on the operations or fulfill the  
32 purposes specified in its charter, and take and hold real and personal property as  
33 security for the payment of funds so invested or loaned;

1 (12) Be a promoter, partner, member, associate, or manager of any  
2 partnership, joint venture, trust, or other enterprise;

3 (13) Make gifts or contributions in cash, other property, or stock or  
4 other securities of the corporation to or for the use of:

5 (i) The United States, this State, another state of the United  
6 States, a territory, possession, or district of the United States, or any institution,  
7 agency, or political subdivision of any of them; and

8 (ii) Any governmental or other organization, whether inside or  
9 outside the United States, for religious, charitable, scientific, civic, public welfare,  
10 literary, or educational purposes;

11 (14) Elect its officers and appoint its agents, define their duties,  
12 determine their compensation, and adopt and carry into effect employee and officer  
13 benefit plans;

14 **(15) RENOUNCE, IN ITS CHARTER OR BY RESOLUTION OF ITS**  
15 **BOARD OF DIRECTORS, ANY INTEREST OR EXPECTANCY OF THE CORPORATION**  
16 **IN, OR IN BEING OFFERED AN OPPORTUNITY TO PARTICIPATE IN, BUSINESS**  
17 **OPPORTUNITIES OR CLASSES OR CATEGORIES OF BUSINESS OPPORTUNITIES**  
18 **THAT ARE:**

19 **(I) PRESENTED TO THE CORPORATION; OR**

20 **(II) DEVELOPED BY OR PRESENTED TO ONE OR MORE OF**  
21 **ITS DIRECTORS OR OFFICERS;**

22 ~~[(15)]~~ **(16)** Adopt, alter, and repeal bylaws not inconsistent with law or  
23 its charter for the regulation and management of its affairs;

24 ~~[(16)]~~ **(17)** Exercise generally the powers set forth in its charter and  
25 those granted by law; and

26 ~~[(17)]~~ **(18)** Do every other act not inconsistent with law which is  
27 appropriate to promote and attain the purposes set forth in its charter.

28 2-309.

29 (c) (1) A division of issued shares into a greater number of shares of the  
30 same class without any change in the aggregate amount of stated capital is a stock  
31 split, and a division with a change in the aggregate amount of stated capital is a stock  
32 dividend within the meaning of this subsection.

1 (2) If authorized by its board of directors and unless the charter  
2 provides otherwise, shares may be issued by a corporation, without consideration to  
3 the holders of one or more classes or series of stock, as a stock split or a stock dividend.

4 (3) If a stock dividend is payable in a corporation's own stock with par  
5 value, the shares shall be issued at par value and, at the time the stock dividend is  
6 paid, the corporation shall transfer from surplus to stated capital an amount at least  
7 equal to the aggregate par value of the shares to be issued.

8 (4) If a stock dividend is payable in a corporation's own stock without  
9 par value, the board of directors shall adopt at the time the stock dividend is declared  
10 a resolution which sets the aggregate amount to be attributed to stated capital with  
11 respect to the shares that constitute the stock dividend and, at the time the stock  
12 dividend is paid, the corporation shall transfer at least that amount from surplus to  
13 stated capital.

14 [(5) A dividend payable in shares of one class of a corporation's stock  
15 may not be declared or paid to the holders of shares of another class of stock unless the  
16 payment has been:

17 (i) Approved by the board of directors in accordance with  
18 specific authority in the charter; or

19 (ii) Approved at a meeting of stockholders by the affirmative  
20 vote of a majority of all the votes entitled to be cast on the matter of each class entitled  
21 to vote on it.]

22 2-310.1.

23 (a) This section applies only to a corporation registered as an open-end  
24 company under the Investment Company Act of 1940.

25 (b) Subject to the provisions of § 2-311 of this subtitle, [if authorized by its  
26 board of directors,] a corporation may redeem shares of its stock from any stockholder  
27 if [the]:

28 (1) **THE** corporation's charter expressly provides for the redemption of  
29 shares of its stock from any stockholder[.

30 (c) (1) Subject to the provisions of § 2-311 of this subtitle, unless  
31 prohibited by its charter, in the case of a corporation whose charter does not expressly  
32 provide for the redemption of shares of its stock, the corporation may redeem shares of  
33 its stock from any stockholder if:] **AND THE BOARD OF DIRECTORS AUTHORIZES**  
34 **THE REDEMPTION; OR**

1                   **(2) (I) THE CORPORATION'S CHARTER DOES NOT EXPRESSLY**  
2 **PROHIBIT THE REDEMPTION OF SHARES OF ITS STOCK;**

3                   **[(i)] (II)** The aggregate net asset value of the shares to be  
4 redeemed from the stockholder is, as of the date of the redemption, **[\$1,000] \$2,000** or  
5 less; and

6                   **[(ii)] (III)** Written notice of the redemption to the stockholder of  
7 record:

8                                   1. Is mailed first-class to the stockholder's last known  
9 address of record;

10                                   2. States that all of the shares will be redeemed; and

11                                   3. Establishes a date for the redemption which is at  
12 least 45 days from the date of the notice.

13                   **[(2)] (C)** The price to be paid for shares redeemed under  
14 **SUBSECTION (B)(2) OF** this [subsection] **SECTION** shall be the aggregate net asset  
15 value of the shares at the close of business on the date of the redemption.

16                   **[(3)] (D)** If certificates representing the shares to be redeemed under  
17 **SUBSECTION (B)(2) OF** this [subsection] **SECTION** have been issued and are not  
18 surrendered for cancellation on the date of redemption:

19                                   **[(i)] (1)** The corporation may withhold payment for the  
20 redeemed shares until the certificates are surrendered for cancellation; and

21                                   **[(ii)] (2)** Except for the right to receive payment of the  
22 redemption price, the stockholder shall cease to have any rights as a stockholder of the  
23 corporation on the date of redemption.

24                   **[(4)] (E)** If the aggregate net asset value of the shares to be redeemed  
25 under **SUBSECTION (B)(2) OF** this [subsection] **SECTION** should increase to an  
26 amount greater than **[\$1,000] \$2,000** between the date of the notice of redemption  
27 and the date of the redemption, then the notice of redemption shall have no further  
28 force or effect.

30                   (a) Each director **AND EACH NOMINEE FOR DIRECTOR** of a corporation  
31 shall have the qualifications required by the charter or bylaws of the corporation.

32 2-404.

1 (b) (1) Except as provided in paragraph (2) of this subsection, at each  
2 annual meeting of stockholders, the stockholders shall elect directors to hold office  
3 until the earlier of:

4 (i) The next annual meeting of stockholders and until their  
5 successors are elected and qualify; [or]

6 (ii) The time provided in the terms of any class or series of stock  
7 pursuant to which such directors are elected; **OR**

8 **(III) THE TIME A DIRECTOR CEASES TO HAVE THE**  
9 **QUALIFICATIONS THAT WERE REQUIRED BY THE CHARTER OR BYLAWS OF THE**  
10 **CORPORATION AT THE TIME THE DIRECTOR WAS ELECTED, IF THE CHARTER OR**  
11 **BYLAWS AT THE TIME THE DIRECTOR WAS ELECTED REQUIRED THE DIRECTOR'S**  
12 **TERM TO END ON A FAILURE TO HAVE THOSE QUALIFICATIONS.**

13 (2) Except for a corporation that has elected to be subject to § 3-803 of  
14 this article, if the directors are divided into classes, the term of office may be provided  
15 in the bylaws, except that:

16 (i) The term of office of a director may not be longer than 5  
17 years or, except in the case of an initial or substitute director, shorter than the period  
18 between annual meetings; and

19 (ii) The term of office of at least one class shall expire each year.

20 2-405.

21 (a) (1) **[In] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
22 **SUBSECTION, IN** case of failure to elect directors at the designated time, the directors  
23 holding over shall continue to [manage the business and affairs] **SERVE AS**  
24 **DIRECTORS** of the corporation until their successors are elected and qualify.

25 **(2) IF THE NUMBER OF DIRECTORS TO BE ELECTED AT THE**  
26 **DESIGNATED TIME, TOGETHER WITH THE NUMBER OF DIRECTORS WHO**  
27 **OTHERWISE WOULD HOLD OVER, EXCEEDS THE NUMBER OF DIRECTORS WHO**  
28 **WERE TO BE ELECTED, THEN THE DIRECTORS WHO WILL HOLD OVER AND**  
29 **CONTINUE TO SERVE AS DIRECTORS OF THE CORPORATION UNTIL THEIR**  
30 **SUCCESSORS ARE ELECTED AND QUALIFY SHALL BE DETERMINED:**

31 **(I) BY A MAJORITY VOTE OF THE DIRECTORS ELECTED AT**  
32 **THE DESIGNATED TIME AND, IF THE BOARD IS CLASSIFIED, ANY DIRECTORS**  
33 **WHOSE TERMS DID NOT EXPIRE AT THE DESIGNATED TIME, WHETHER OR NOT**  
34 **SUFFICIENT TO CONSTITUTE A QUORUM; OR**

1                                   **(II) AS OTHERWISE PROVIDED IN THE CHARTER OR BYLAWS**  
2 **OF THE CORPORATION.**

3           (b) A director not elected annually in accordance with § 2–501(b) of this title  
4 shall be deemed to be continuing in office and shall not be deemed to be holding over  
5 under subsection (a) of this section until after the time at which an annual meeting is  
6 required to be held under § 2–501(b) of this title or the charter or bylaws of the  
7 corporation.

8 2–408.

9           (c) Any action required or permitted to be taken at a meeting of the board of  
10 directors or of a committee of the board may be taken without a meeting if a  
11 unanimous consent which sets forth the action is:

12                           (1) Given in writing or by electronic transmission by each member of  
13 the board or committee **ENTITLED TO VOTE ON THE MATTER**; and

14                           (2) Filed in paper or electronic form with the minutes of proceedings of  
15 the board or committee.

16           (d) (1) The charter may provide that one or more directors or a class of  
17 directors shall have more or less than one vote per director on any matter.

18                           (2) If the charter provides that one or more directors shall have more  
19 or less than one vote per director on any matter, every reference in this article to a  
20 majority or other proportion of directors shall refer to a majority or other proportion of  
21 votes **[of] ENTITLED TO BE CAST BY** the directors.

22 2–502.

23           (e) **[The] UNLESS THE CHARTER OR BYLAWS EXPRESSLY PROVIDE**  
24 **OTHERWISE, THE** board of directors has the sole power to fix:

25                           (1) The record date for determining stockholders entitled to request a  
26 special meeting of the stockholders and the record date for determining stockholders  
27 entitled to notice of and to vote at the special meeting; and

28                           (2) The date, time, and place, if any, and the means of remote  
29 communication, if any, by which stockholders and proxy holders may be considered  
30 present in person and may vote at the special meeting.

31 2–507.

32           (d) (1) A proxy is revocable by a stockholder at any time without condition  
33 or qualification unless:



- 1 (i) The proxy states that it is irrevocable; and
- 2 (ii) The proxy is coupled with an interest.
- 3 (2) A proxy may be made irrevocable for as long as it is coupled with  
4 an interest.
- 5 (3) The interest with which a proxy may be coupled includes an  
6 interest in the stock to be voted under the proxy, **AN INTEREST AS A PARTY TO A**  
7 **VOTING AGREEMENT CREATED IN ACCORDANCE WITH § 2-510.1 OF THIS**  
8 **SUBTITLE**, or another general interest in the corporation or its assets or liabilities.

9 **2-510.1.**

10 **TWO OR MORE STOCKHOLDERS OF A CORPORATION MAY ENTER INTO A**  
11 **WRITTEN AGREEMENT THAT SPECIFIES THAT, IN EXERCISING ANY VOTING**  
12 **RIGHTS, THE STOCK HELD BY THE PARTIES TO THE AGREEMENT SHALL BE**  
13 **VOTED:**

- 14 (1) **AS PROVIDED IN THE AGREEMENT;**
- 15 (2) **AS THE PARTIES MAY AGREE; OR**
- 16 (3) **BASED ON A PROCEDURE SET FORTH IN THE AGREEMENT.**

17 **3-104.**

18 (a) Notwithstanding any other provision of this subtitle, unless the charter  
19 or bylaws of a corporation provide otherwise **BY REFERENCE TO THIS SECTION OR**  
20 **THE SUBJECT MATTER OF THIS SECTION**, the approval of the stockholders and  
21 articles of transfer or share exchange, as the case may be, are not required for any:

- 22 (1) Transfer of assets by a corporation in the ordinary course of  
23 business actually conducted by it or as a distribution as defined in § 2-301 of this  
24 article;
- 25 (2) Mortgage, pledge, or creation of any other security interest in any  
26 or all of the assets of a corporation, whether or not in the ordinary course of its  
27 business;
- 28 (3) Exchange of shares of stock through voluntary action or under any  
29 agreement with the stockholders;

1           (4)    Transfer of assets by a corporation to one or more persons if all of  
2 the equity interests of the person or persons are owned, directly or indirectly, by the  
3 corporation; or

4           (5)    Transfer of assets by a corporation registered as an open-end  
5 investment company under the Investment Company Act of 1940.

6   3-105.

7           (a)    A consolidation, merger, share exchange, or transfer of assets shall be  
8 approved in the manner provided by this section, except that:

9           (1)    A merger of a 90 percent or more owned subsidiary with or into its  
10 parent need be approved only in accordance with the provisions of § 3-106 of this  
11 subtitle;

12                   **(2)    A MERGER OF A MARYLAND CORPORATION IN ACCORDANCE**  
13 **WITH § 3-106.1 OF THIS SUBTITLE NEED BE APPROVED ONLY IN THE MANNER**  
14 **PROVIDED IN § 3-106.1 OF THIS SUBTITLE;**

15                   **[(2)] (3)**    A share exchange need be approved by a Maryland successor  
16 only by its board of directors and by any other action required by its charter;

17                   **[(3)] (4)**    A transfer of assets need be approved by a Maryland  
18 transferee corporation only by its board of directors and by any other action required  
19 by its charter;

20                   **[(4)] (5)**    A foreign corporation party to the transaction shall have the  
21 transaction advised, authorized, and approved in the manner and by the vote required  
22 by its charter and the laws of the place where it is organized;

23                   **[(5)] (6)**    A merger need be approved by a Maryland successor  
24 corporation only by a majority of its entire board of directors if:

25                   (i)    The merger does not reclassify or change the terms of any  
26 class or series of its stock that is outstanding immediately before the merger becomes  
27 effective or otherwise amend its charter and the number of its shares of stock of such  
28 class or series outstanding immediately after the effective time of the merger does not  
29 increase by more than 20 percent of the number of its shares of the class or series of  
30 stock that is outstanding immediately before the merger becomes effective; or

31                   (ii)   There is no stock outstanding or subscribed for and entitled  
32 to be voted on the merger; and

1           **[(6)] (7)**     A business trust party to a merger shall have the merger  
2 advised, authorized, and approved in the manner and by the vote required by its  
3 declaration of trust and the laws of the place where it is organized.

5           **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE**  
6 **MEANINGS INDICATED.**

7                   **(2) “ACQUIRING ENTITY” MEANS THE MARYLAND CORPORATION**  
8 **OR OTHER ENTITY, AS DEFINED IN § 3-901 OF THIS TITLE, CONSUMMATING A**  
9 **TENDER OR EXCHANGE OFFER UNDER THIS SECTION.**

10                   **(3) “STOCKHOLDER” INCLUDES A SHAREHOLDER OF A REAL**  
11 **ESTATE INVESTMENT TRUST.**

12                   **(4) (I) “SUBJECT CORPORATION” MEANS THE MARYLAND**  
13 **CORPORATION THAT IS THE SUBJECT OF A TENDER OR EXCHANGE OFFER**  
14 **UNDER THIS SECTION.**

15                           **(II) “SUBJECT CORPORATION” INCLUDES A MARYLAND**  
16 **REAL ESTATE INVESTMENT TRUST AS DEFINED IN TITLE 8 OF THIS ARTICLE.**

17           **(B) THIS SECTION APPLIES ONLY TO AN AGREEMENT TO MERGE THAT**  
18 **PROVIDES FOR THE CONSUMMATION OF THE MERGER ON OR AFTER OCTOBER**  
19 **1, 2014.**

31 **FOLLOWING THE CONSUMMATION OF THE OFFER DESCRIBED IN ITEM (3) OF**  
32 **THIS SUBSECTION;**

1           **(3) AN ACQUIRING ENTITY CONSUMMATES A TENDER OR**  
2 **EXCHANGE OFFER FOR ANY AND ALL OF THE OUTSTANDING SHARES OF THE**  
3 **SUBJECT CORPORATION THAT WOULD, EXCEPT FOR THE APPLICATION OF THIS**  
4 **SECTION, ENTITLE THE HOLDER OF THE OUTSTANDING SHARES TO VOTE ON**  
5 **THE MERGER ON THE TERMS PROVIDED IN THE AGREEMENT TO MERGE;**

6           **(4) FOLLOWING THE CONSUMMATION OF THE OFFER, THE**  
7 **ACQUIRING ENTITY OWNS AT LEAST THAT PERCENTAGE OF THE SHARES, AND**  
8 **OF EACH CLASS OR SERIES OF THE SHARES, OF THE SUBJECT CORPORATION**

23 have the merger advised, authorized, and approved in the manner and by the vote  
24 required by the laws of the place where it is organized; and

25 (ii) A domestic limited liability company shall have the merger  
26 approved in the manner provided under § 4A-703 of this article;

27 (3) A merger need be approved by a Maryland real estate investment  
28 trust successor only by a majority of its entire board of trustees if the merger does not  
29 reclassify or change the terms of any class or series of its shares that are outstanding  
30 immediately before the merger becomes effective or otherwise amend its declaration of  
31 trust and the number of shares of such class or series outstanding immediately after  
32 the effective time of the merger does not increase by more than 20 percent of the  
33 number of its shares of the class or series of shares outstanding immediately before  
34 the merger becomes effective; [and]



1           (4) A merger of a subsidiary with or into its parent need be approved  
2 only in the manner provided in § 3–106 of this article, provided the parent owns at  
3 least 90 percent of the subsidiary; AND

4           **(5) A MERGER OF A MARYLAND REAL ESTATE INVESTMENT**  
5 **TRUST IN ACCORDANCE WITH § 3–106.1 OF THIS ARTICLE NEED BE APPROVED**  
6 **ONLY IN THE MANNER PROVIDED IN § 3–106.1 OF THIS ARTICLE.**

8           (c) An other entity may convert to a real estate investment trust by  
9 complying with § 8–702 of this subtitle and filing for record with the Department:

10           (1) Articles of conversion executed in the manner required by Title 1 of  
11 this article; and

12           (2) A declaration of trust, which shall include the name of the  
13 converting other entity, executed in the manner required by [Title 1 of this article] §
