1 AN ACT concerning

Dentists - Saliva Lead Poisoning Screening Tests - Scope of Practice and Requirements

FOR the purpose of altering the definition of "practice dentistry" to include the collection 4 $\mathbf{5}$ of oral saliva samples to screen for lead poisoning; authorizing a dentist to collect 6 oral saliva samples to screen for lead poisoning in individuals under a certain age; 7 requiring the dentist to send a certain sample for analysis to a certain laboratory; 8 requiring a dentist to send a certain notice to the parents or legal guardian of a 9 certain child and certain information to the Department of the Environment in accordance with certain provisions of law; providing for the construction of certain 1011 provisions of this Act; and generally relating to saliva lead poisoning screening tests 12and dentists.
