Health Care Facilities - Certificate of Need - Modifications

3 FOR the purpose of altering repealing a provision of law exempting certain offices from 4 certificate of need requirements under certain circumstances; providing that a 5 certificate of need is required before the type or scope of any health care service is 6 changed if the health care service results in a change in operating room capacity in 7 a certain hospital health care facilities; altering the circumstances under which a 8 certificate of need is required before certain capital expenses are made by or on 9 behalf of a certain health care facility; authorizing the Maryland Health Care 10 Commission to establish an abbreviated review process for certain applications for a 11 certificate of need; repealing a provision of law authorizing a hospital to acquire a freestanding ambulatory surgical facility or a certain office or group practice under 12 13 certain circumstances; providing that a certain certificate of need application is 14 deemed approved under certain circumstances; repealing a provision of law 15 providing for the construction of certain provisions of law governing certificates of need; providing for the application of certain provisions of this Act; altering a certain 16 definition; and generally relating to certificates of need. 17
