### 9 A PERSON WHO SOLICITS ANOTHER OR CONSPIRES WITH ANOTHER TO 10 COMMIT MURDER IN THE FIRST DEGREE IS GUILTY OF A FELONY AND ON 11 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING LIFE.
