A BILL ENTITLED

1 AN ACT concerning

2 **Natural Resources – Sunday Hunting – Migratory Game Birds**

3 FOR the purpose of authorizing the Department of Natural Resources to allow a person to
4 hunt any migratory game birds on Sundays during the open season on certain
5 property; making a conforming change; and generally relating to hunting migratory
6 game birds on Sundays.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Natural Resources**

2 (a) (1) Except as otherwise provided in this subsection, a person may not hunt
3 any game bird or mammal on Sundays.

4 (8) (i) This paragraph applies only in Allegany County, Garrett County,
5 and Washington County.

6 (ii) The Department may allow a person to hunt any game bird or
7 game mammal[, except migratory game birds and wetland game birds,] on a Sunday during
8 the open season for that game bird or game mammal on:

9 1. Private property, subject to § 10-411 of this subtitle; and

10 2. Public land that is designated for Sunday hunting by the
11 Department.

12 **(12) THE DEPARTMENT MAY ALLOW A PERSON TO HUNT ANY**
13 **MIGRATORY GAME BIRDS ON SUNDAYS DURING THE OPEN SEASON ON:**

14 **(I) PRIVATE PROPERTY, SUBJECT TO § 10-411 OF THIS**
15 **SUBTITLE; AND**

16 **(II) PUBLIC LAND THAT IS DESIGNATED FOR SUNDAY HUNTING**
17 **BY THE DEPARTMENT.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2019.
