CHAPTER _____

1 AN ACT concerning

2 **Queen Anne's County – Alcoholic Beverages – Beauty Salon and Barbershop**
3 **License**

4 FOR the purpose of establishing a beauty salon and barbershop beer and wine license in
5 Queen Anne's County; authorizing the Board of License Commissioners to issue the
6 license to a holder of certain permits; specifying that the license authorizes the
7 license holder to sell beer or wine by the glass for on-premises consumption to a
8 customer while the customer is provided certain services; authorizing a customer to
9 consume only a certain amount of wine or beer during any one visit; prohibiting the
10 license from being transferred to another location; setting the hours of sale for the
11 license; specifying that an establishment for which the license is issued is subject to
12 certain alcohol awareness training requirements; setting an annual license fee; and
13 generally relating to alcoholic beverages licenses in Queen Anne's County.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That Section(s) 27–1001 of Article – Alcoholic Beverages of the Annotated Code of Maryland
9 be renumbered to be Section(s) 27–1001.1.

10 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
11 as follows:

12 **Article – Alcoholic Beverages**

13 27–102.

14 This title applies only in Queen Anne’s County.

16 **(A) THERE IS A BEAUTY SALON AND BARBERSHOP BEER AND WINE LICENSE.**

17 **(B) THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF:**

18 **(1) A BEAUTY SALON PERMIT ISSUED UNDER § 5–501 OF THE**
19 **BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

20 **(2) A BARBERSHOP PERMIT ISSUED UNDER § 4–301 OF THE BUSINESS**
21 **OCCUPATIONS AND PROFESSIONS ARTICLE.**

22 **(C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER OR**
23 **WINE BY THE GLASS FOR ON–PREMISES CONSUMPTION TO A CUSTOMER WHILE THE**
24 **CUSTOMER IS PROVIDED:**

25 **(1) A COSMETOLOGY SERVICE UNDER § 5–101(N) OF THE BUSINESS**
26 **OCCUPATIONS AND PROFESSIONS ARTICLE OR AN ESTHETIC SERVICE UNDER §**
27 **5–101(O) OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE; OR**

28 **(2) A BARBERING SERVICE UNDER § 4–101(L) OF THE BUSINESS**
29 **OCCUPATIONS AND PROFESSIONS ARTICLE.**

30 **(D) A CUSTOMER MAY CONSUME NOT MORE THAN 5 OUNCES OF WINE OR 12**
31 **OUNCES OF BEER DURING ANY ONE VISIT.**

1 ~~(D)~~ **(E)** THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER
2 LOCATION.

3 ~~(E)~~ **(F)** THE LICENSE HOLDER MAY PROVIDE BEER AND WINE DURING
4 NORMAL BUSINESS HOURS BUT NOT LATER THAN 9 P.M.

5 ~~(F)~~ **(G)** AN ESTABLISHMENT FOR WHICH THE LICENSE IS ISSUED IS
6 SUBJECT TO THE ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4-505
7 OF THIS ARTICLE.

8 ~~(G)~~ **(H)** THE ANNUAL LICENSE FEE IS \$100.

9 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2019.
