## A BILL ENTITLED

1 AN ACT concerning 2 Family Investment Program - Temporary Cash Assistance - Funding 3 FOR the purpose of requiring the Governor to provide sufficient funds in the budget to 4 ensure that the value of temporary cash assistance, combined with federal food 5 stamps, is equal to at least certain percentages of the State minimum living level for 6 certain fiscal years; and generally relating to temporary cash assistance. 7 BY repealing and reenacting, with amendments, 8 Article – Human Services 9 Section 5–316(a) 10 Annotated Code of Maryland 11 (2007 Volume and 2018 Supplement) 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: 13 14 Article - Human Services 15 5-316. 16 Except as provided in paragraph (2) of this subsection, the Governor shall provide sufficient funds in the budget to: 17 18 ensure that the value of temporary cash assistance, combined (i) 19 with federal food stamps, is equal to at least: 20 1. FOR FISCAL YEAR 2020, 61% of the State minimum 21living level; [and] 22 2. FOR FISCAL YEAR 2021, 63% OF THE STATE MINIMUM

- 12 (2) The funds provided under this subsection may be less than the amount
- 13 required under paragraph (1) of this subsection if the Governor reports to the General
- 14 Assembly, in accordance with § 2–1246 of the State Government Article, on the reasons for
- 15 the reduced funding for temporary cash assistance and food stamps.
- 16 (3) This subsection does not limit the flexibility of local departments
- 17 regarding the provision of services.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 19 October 1, 2019.
