19 (A) IN THIS SECTION, "METHADONE TREATMENT FACILITY" MEANS A 20 FACILITY AT WHICH METHADONE IS ADMINISTERED IN THE TREATMENT, 21 MAINTENANCE, OR DETOXIFICATION OF INDIVIDUALS.

(B) A METHADONE TREATMENT FACILITY MAY NOT BE ESTABLISHED OR
OPERATED WITHIN 500 FEET OF A PUBLIC OR PRIVATE SCHOOL, A CHILD CARE
CENTER LICENSED BY THE DEPARTMENT OF HUMAN RESOURCES, OR ANY OTHER

1 CHILD-SERVING AGENCY UNLESS THE DEPARTMENT RECEIVES FROM EACH 2 SCHOOL, LICENSED CHILD CARE CENTER, AND CHILD-SERVING AGENCY LOCATED 3 WITHIN 500 FEET OF THE FACILITY A LETTER OF SUPPORT FOR THE LOCATION OF 4 THE FACILITY.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2016.
