## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2009 – Prince George’s County**  
3 **– National Children’s Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2009  
5 to extend the deadline for the Board of Directors of the National Children’s  
6 Museum, Inc. to present evidence that a matching fund will be provided;  
7 requiring that the Board of Public Works expend or encumber the proceeds of  
8 the loan by June 1, 2013; and generally relating to amending the Maryland  
9 Consolidated Capital Bond Loan of 2009.

10 BY repealing and reenacting, with amendments,  
11 Chapter 485 of the Acts of the General Assembly of 2009  
12 Section 1(3) Item ZA02(G) and ZA03(F)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Chapter 485 of the Acts of 2009**

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That:

18 (3) ZA02 HOUSE OF DELEGATES LEGISLATIVE INITIATIVES

19 (G) National Children’s Museum. Provide a grant equal to the  
20 lesser of (i) \$1,750,000 or (ii) the amount of the matching fund  
21 provided, to the Board of Directors of the National Children’s  
22 Museum, Inc. for the acquisition, design, construction, and  
23 capital equipping of the new National Children’s Museum in  
24 Oxon Hill. Notwithstanding the provisions of Section 1(5) of  
25 this Act, the matching fund may consist of funds expended

 20 **1(7) OF THIS ACT, THE PROCEEDS OF THE LOAN MUST BE**  
 21 **EXPENDED OR ENCUMBERED BY THE BOARD OF PUBLIC**  
 22 **WORKS FOR THE PURPOSES PROVIDED IN THIS ACT NO**  
 23 **LATER THAN JUNE 1, 2013** (Statewide) .....

 25 June 1, 2011.
