2 Real Property – Age 55 and Older – Residential Leases

- 3 FOR the purpose of requiring a landlord to offer a 36-month residential lease for 4 certain properties offered for rent to individuals above a certain age; limiting 5 the application of this Act to properties that are composed of a minimum 6 number of dwelling units; limiting the application of this Act to properties that 7 have received funding from the State used for construction of or improvement to 8 a structure under certain conditions; requiring the 36-month residential lease 9 to be offered to certain lessees; and generally relating to the lease of residential 10 properties.
