14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:				
16	Article - Health Occupations				
17	12–403.				
18 19	(a) This section does not require a nonresident pharmacy to violate the laws or regulations of the state in which it is located.				
20 21	(b) Except as otherwise provided in this section, a pharmacy for which a pharmacy permit has been issued under this title:				
22	(1) Shall be operated in compliance with the law and with the rules				

and regulations of the Board;



1 2	(2) Shall be located and equipped so that the pharmacy may be operated without endangering the public health or safety;
3 4 5	(3) Shall ensure that a licensed pharmacist be immediately available on the premises to provide pharmacy services at all times the pharmacy is in operation;
6 7	(4) Shall be supervised by a licensed pharmacist who is responsible for the operations of the pharmacy at all times the pharmacy is in operation;
8 9	(5) Shall provide complete pharmaceutical service by preparing and dispensing all prescriptions that reasonably may be expected of a pharmacist;
10 11 12	(6) Shall provide services to the general public and may not restrict or limit its services to any group of individuals unless granted a waiver from this requirement by the Board;
13 14 15	(7) May not offer pharmaceutical services under any term or condition that tends to interfere with or impair the free and complete exercise of professional pharmaceutical judgment or skill;
16 17	(8) May not make any agreement that denies a patient a free choice of pharmacist or pharmacy services;
18 19 20	(9) May not participate in any activity that is a ground for Board action against a licensed pharmacist under $12-313$ or a registered pharmacy technician under $12-6B-09$ of this title;
21 22	(10) (i) Shall maintain at all times a current reference library that is appropriate to meet the needs of:
23	1. The practice specialty of that pharmacy; and
24	2. The consumers the pharmacy serves; and
25 26 27	(ii) Shall comply with any regulations adopted by the Board establishing the types of texts required to be included in the reference libraries in each of the various practice specialty pharmacies;
28 29	(11) (i) Shall maintain at all times the minimum professional and technical equipment and sanitary appliances that are necessary in a pharmacy:
30	1. To prepare and dispense prescriptions properly; and
31	2. To otherwise operate a pharmacy; and
32	(ii) Shall:

$\frac{1}{2}$	1. Be equipped with the minimum equipment and appliances specified by the Board under this section; and		
3	2. Be kept in a clean and orderly manner;		
4 5	(12) Shall store all prescription or nonprescription drugs or devices properly and safely subject to the rules and regulations adopted by the Board;		
6	(13) Shall:		
7 8	(i) Make and keep on file for at least 5 years a record of each prescription prepared or dispensed in the pharmacy;		
9 10 11 12	(ii) Disclose the records and files maintained of prescriptions for drugs or devices that identify or may be readily associated with the identity of a patient only in accordance with the provisions of Title 4, Subtitle 3 of the Health – General Article; and		
13 14	(iii) Keep additional records as required by the rules and regulations adopted by the Board;		
15 16 17 18 19 20	(14) Except as otherwise provided under federal law, shall establish and maintain mechanisms to ensure that all prescription drugs or devices used within institutions that provide acute, subacute, or long—term care, or within their related corporate subsidiaries, but stored outside a pharmacy, are stored properly and safely, subject to rules and regulations adopted by the Board and policies established by the institution;		
21 22 23 24	(15) Shall provide such personnel, automation, and technology as are necessary to allow the licensed pharmacist employee sufficient time to utilize the pharmacist's knowledge and training and to perform competently the functions of a licensed pharmacist as required by law;		
25 26 27	(16) Shall provide such personnel, automation, and technology as are necessary to [allow the licensed pharmacist employee or registered pharmacy technician to] comply with the labeling requirements specified in § 12–505 of this title;		
28 29 30 31	(17) With regard to a prescription drug that is delivered in this State by the United States mail, a common carrier, or a delivery service and is not personally hand delivered directly to a patient or to the agent of the patient at the residence of the patient or at another location designated by the patient, shall:		
32 33	(i) Provide a general written notice in each shipment of a prescription drug that alerts a consumer that, under certain circumstances, a		

medication's effectiveness may be affected by exposure to extremes of heat, cold, or

1 2 3 4	(ii) Provide a specific written notice in each shipment of a prescription drug that provides a consumer with a toll–free or local consumer access telephone number accessible during regular hours of operation, which is designed to respond to consumer questions pertaining to medications;
5 6 7	(18) (i) May maintain a record log of any prescription that is requested to be filled or refilled by a patient in accordance with the provisions of Title 4, Subtitle 3 of the Health – General Article;
8 9	(ii) If the prescription record of a patient includes the patient's Social Security number, shall keep the Social Security number confidential;
10 11 12	(iii) May not list in the record log the type of illness, disability, or condition that is the basis of any dispensing or distribution of a drug by a pharmacist; and
13 14 15	(iv) May not list a patient's Social Security number, illness, disability, or condition, or the name and type of drug received in the record log if the log is available to other pharmacy customers;
16 17	(19) May not allow an unauthorized individual to represent that the individual is a pharmacist or registered pharmacy technician;
18 19	(20) Shall provide information regarding the process for resolving incorrectly filled prescriptions in accordance with existing regulations by:
20 21	(i) Posting a sign that is conspicuously positioned and readable by consumers at the point where prescription drugs are dispensed to consumers; or
22 23	(ii) Including written information regarding the process with each prescription dispensed; and
24 25	(21) Shall dispense or dispose of prescription drugs or medical supplies in accordance with Title 15, Subtitle 6 of the Health – General Article.
26 27 28	(c) (1) The Board may waive any of the requirements of this section for the University of Maryland School of Pharmacy, for nuclear pharmacy and dental pharmacy experimental and teaching programs.

## DISPENSE DEVICES IN ACCORDANCE WITH RULES AND REGULATIONS ADOPTED 1 2 BY THE BOARD. 3 [(3)]**(4)** The Board shall waive the requirements of subsection (b)(20) of this section for a pharmacy owned and operated by a hospital, nursing facility, or 4 clinic to which the public does not have access to purchase pharmaceuticals on a retail 5 6 basis. 7 (d) A nonresident pharmacy shall: 8 (1) Hold a pharmacy permit issued by the Board; and 9 (2) Have a pharmacist on staff who is: Licensed by the Board; and 10 (i) 11 Designated as the pharmacist responsible for providing (ii) pharmaceutical services to patients in the State. 12 13 In order to obtain a pharmacy permit from the Board, a nonresident pharmacy shall: 14 15 Submit an application to the Board on the form that the (i) 16 Board requires; 17 (ii) Pay to the Board an application fee set by the Board; 18 (iii) Submit a copy of the most recent inspection report resulting 19 from an inspection conducted by the regulatory or licensing agency of the state in 20 which the nonresident pharmacy is located; and 21On the required permit application, identify the name and 22current address of an agent located in this State officially designated to accept service 23 of process. 24A nonresident pharmacy shall report a change in the name or 25 address of the resident agent in writing to the Board 30 days prior to the change. 26 (f) Notwithstanding subsection (a) of this section, a nonresident pharmacy 27 shall: 28 Comply with the requirements of subsection (b)(2), (7) through (1) 29 (12), and (19) OF THIS SECTION when:

30 (i) Dispensing prescription drugs or prescription devices to a 31 patient in this State; or

(ii) Otherwise engaging in the practice of pharmacy in the State;	
(2) On an annual basis and within 30 days after a change of offic corporate officer, or pharmacist, disclose to the Board the location, names, and titles all principal corporate officers and all pharmacists who are dispensing prescription for drugs or devices to persons in this State;	
(3) Comply with all lawful directions and requests for informati from the regulatory or licensing agency of the state in which it is located and requests for information made by the Board pursuant to this section;	
(4) Maintain at all times a valid, unexpired permit to conduct pharmacy in compliance with the laws of the state in which it is located;	
(5) Maintain its records of prescription drugs or devices dispensed patients in this State so that the records are readily retrievable;	
(6) During its regular hours of operation, but not less than 6 days a week, and for a minimum of 40 hours per week, provide toll—free telephone service to facilitate communication between patients in this State and a pharmacist <b>OR AN INDIVIDUAL</b> who:	
(i) Has access to the patient's prescription records; and	
(ii) Is required to refer patients in the State to the responsible pharmacist licensed in the State, as appropriate;	
(7) Disclose its toll–free telephone number on a label affixed to eacontainer of drugs or devices;	
(8) Comply with the laws of this State relating to the confidentiality prescription records if there are no laws relating to the confidentiality of prescripting records in the state in which the nonresident pharmacy is located; and	
(9) Comply with the requirements of subsection (b)(17) and (20) of the section.	
(g) Subject to the hearing provisions of § 12–411 of this subtitle, if pharmacy or a nonresident pharmacy is operated in violation of this section, the Boa may suspend the applicable pharmacy permit until the pharmacy complies with the section.	

(H) THE BOARD MAY WAIVE THE FOLLOWING REQUIREMENTS FOR NONRESIDENT PHARMACIES THAT ONLY DISPENSE DEVICES IN ACCORDANCE WITH RULES AND REGULATIONS ADOPTED BY THE BOARD:

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
