## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Charles County – Old**  
3 **Waldorf School Community Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007  
5 to permit the Board of Directors of the Friends of Old Waldorf School  
6 Foundation, Inc. to include funds expended on or after a certain date in the  
7 matching fund; and extending the deadline by which the grantee must present  
8 evidence that a matching fund will be provided.

9 BY repealing and reenacting, with amendments,  
10 Chapter 488 of the Acts of the General Assembly of 2007  
11 Section 1(3) Item ZA02(AM)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 488 of the Acts of 2007**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That:

17 (3) ZA02 LOCAL SENATE INITIATIVES

18 (AM) Old Waldorf School Community Center. Provide a grant equal  
19 to the lesser of (i) \$100,000 or (ii) the amount of the matching  
20 fund provided, to the Board of Directors of the Friends of Old  
21 Waldorf School Foundation, Inc. for the construction, repair,  
22 renovation, reconstruction, and capital equipping of the Old  
23 Waldorf School for use as a community center, located in  
24 Waldorf. Notwithstanding Section 1(5) of this Act, the  
25 matching fund may consist of in kind contributions or funds
