A BILL ENTITLED

1 AN ACT concerning

$\mathbf{2}$ Labor and Employment - Maryland Healthy Working Families Act - Seasonal 3 **Temporary Workers**

4 FOR the purpose of altering the period during which an employer is not required to allow $\mathbf{5}$ an employee to use earned sick and safe leave; altering the circumstances under 6 which an employer is required to reinstate certain unused sick and safe leave; 7 altering the circumstances under which an employer is authorized to require an 8 employee who uses earned sick and safe leave to provide certain verification; making 9 this Act an emergency measure; and generally relating to the Maryland Healthy Working Families Act. 10

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency 2 measure, is necessary for the immediate preservation of the public health or safety, has 3 been passed by a yea and nay vote supported by three—fifths of all the members elected to 4 each of the two Houses of the General Assembly, and shall take effect from the date it is 5 enacted.
