# Natural Resources - Recreational License Donation Program <u>and Fund</u> <del>Program Extension and Monetary Donations via Electronic Licensing</del> <u>Revisions</u>

FOR the purpose of changing the name of the Recreational License Donation Fund to the 4 Healing Heroes Hunting and Fishing Fund; requiring the Department of Natural  $\mathbf{5}$ 6 Resources to establish a process for an individual purchasing certain licenses and 7 stamps in a certain manner to make a voluntary monetary donation to the 8 Recreational License Donation Fund; requiring the Department to collect donations 9 and deposit them into the Fund; authorizing the Fund to be used for grants to certain 10 eligible sponsor organizations that provide recreational hunting or fishing 11 opportunities for Gold Star recipients or certain disabled persons; authorizing the Department to make grants to eligible sponsor organizations; specifying the 12 purposes for which a grant awarded to an eligible sponsor organization may be used; 13expanding the contents of the Fund to include donations made under this Act; 14 defining a certain term; making conforming changes; extending the termination date 1516 for certain provisions of law establishing the recreational license donation program; providing for the termination of this Act; making a stylistic change; and generally 1718 relating to the recreational license donation program and the Healing Heroes 19Hunting and Fishing Fund.
