RESOLUTION, Proposing an Amendment to the Constitution of Maine to Extend the Time That a Signature on a Petition for a Direct Initiative of Legislation Is Valid

Presented by Senator BENNETT of Oxford. Cosponsored by Senators: BRAKEY of Androscoggin, HICKMAN of Kennebec. 1 **Constitutional amendment. Resolved:** Two thirds of each branch of the 2 Legislature concurring, that the following amendment to the Constitution of Maine be 3 proposed:

Constitution, Art. IV, Pt. Third, §18, sub-§2 is amended to read:

5 2. Referral to electors unless enacted by the Legislature without change; number of signatures necessary on direct initiative petitions; dating signatures 6 on petitions; competing measures. For any measure thus proposed by electors, the 7 number of signatures shall not be less than 10% of the total vote for Governor cast in the 8 9 last gubernatorial election preceding the filing of such petition. The date each signature 10 was made shall be written next to the signature on the petition. A signature is not valid if it is dated more than one year 18 months prior to the date that the petition was filed in the 11 office of the Secretary of State. The measure thus proposed, unless enacted without change 12 by the Legislature at the session at which it is presented, shall be submitted to the electors 13 together with any amended form, substitute, or recommendation of the Legislature, and in 14 15 such manner that the people can choose between the competing measures or reject both. When there are competing bills and neither receives a majority of the votes given for or 16 against both, the one receiving the most votes shall at the next statewide election to be held 17 18 not less than 60 days after the first vote thereon be submitted by itself if it receives more 19 than 1/3 of the votes given for and against both. If the measure initiated is enacted by the Legislature without change, it shall not go to a referendum vote unless in pursuance of a 20 21 demand made in accordance with the preceding section. The Legislature may order a special election on any measure that is subject to a vote of the people. 22

Constitutional referendum procedure; form of question; effective date. Resolved: That the municipal officers of this State shall notify the inhabitants of their respective cities, towns and plantations to meet, in the manner prescribed by law for holding a statewide election, at a statewide election held in the month of November following the passage of this resolution, to vote upon the ratification of the amendment proposed in this resolution by voting upon the following question:

"Do you favor amending the Constitution of Maine to extend from one year to 18 months the period of time that signatures are valid on a petition for a direct initiative of legislation?"

32 The legal voters of each city, town and plantation shall vote by ballot on this question and designate their choice by a cross or check mark placed within the corresponding square 33 below the word "Yes" or "No." The ballots must be received, sorted, counted and declared 34 35 in open ward, town and plantation meetings and returns made to the Secretary of State in the same manner as votes for members of the Legislature. The Governor shall review the 36 returns. If it appears that a majority of the legal votes are cast in favor of the amendment, 37 the Governor shall proclaim that fact without delay and the amendment becomes part of 38 39 the Constitution of Maine on the date of the proclamation.

40 Secretary of State shall prepare ballots. Resolved: That the Secretary of State
41 shall prepare and furnish to each city, town and plantation all ballots, returns and copies of
42 this resolution necessary to carry out the purposes of this referendum.
