## SUMMARY

This amendment strikes and replaces the bill and the title. The amendment adds aggravated sex trafficking and sex trafficking offenses and aggravated criminal forced

labor and criminal forced labor offenses to the offenses subject to criminal forfeiture of 1 assets pursuant to a court procedure specified in statute, after a criminal conviction, and 2 with distribution of the forfeited property or proceeds of the forfeited property in 3 accordance with statute and as ordered by the court. The amendment broadens one of the 4 allowable uses of the property forfeited or the proceeds of the property. In current law, 5 property or proceeds may be given to a law enforcement agency in this State that 6 provides case management and other social services to persons with substance use 7 disorders; in the amendment, property or proceeds may be given to a law enforcement 8 9 agency that provides case management and other social services to persons affected by crimes that are subject to forfeiture of property. 10
