SUBSTITUTE FOR SENATE BILL NO. 376

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"

(MCL 760.1 to 777.69) by adding section 34a to chapter IX.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT: CHAPTER IX

2	Sec. 34a. (1) The Michigan sentencing commission is created in
3	the legislative council. The legislative council shall provide the
4	commission with suitable office space, staff, and necessary
5	equipment. The commission consists of the chairperson appointed by
6	the governor under subsection (4) and all of the following members:

(a) Two individuals who are members of the senate, consisting of 1 member from each caucus appointed by the leader of that caucus.

- 1 (b) Two individuals who are members of the house of
 2 representatives, consisting of 1 member from each caucus appointed
 3 by the leader of that caucus.
 - (c) The attorney general or the attorney general's designee.
- 5 (d) One individual who is a circuit court judge, serving in a 6 county with a population of less than 800,000, appointed from a 7 list of 3 names submitted by the Michigan Judges Association.
 - (e) One individual who is a circuit court judge, serving in a county with a population of more than 800,000, appointed from a list of 3 names submitted by the Michigan Judges Association.
 - (f) One individual who represents law enforcement, appointed from a list of 3 names not all of whom are affiliated with the same political party, submitted by the Michigan Sheriffs' Association.
- (g) One individual who represents the prosecuting attorneys of this state, appointed from a list of 3 names not all of whom are affiliated with the same political party, submitted by the Prosecuting Attorneys Association of Michigan.
- (h) One individual who is an attorney in good standing
 appointed from a list of 3 names submitted by the Criminal Defense
 Attorneys of Michigan.
- 21 (i) One individual who is a member of a nongovernmental 22 nonprofit that serves victims and represents victim service 23 providers.
 - (j) One individual who was previously incarcerated.
- 25 (k) One individual who works in the mental or behavioral 26 health field.
- 27 (*l*) The director of the Michigan department of corrections or 28 the director's designee.
- 29 (2) Before January 1, 2024, the speaker of the house of

- 1 representatives shall appoint 1 of the commission members described
- 2 in subsection (1)(d) and (e) and the minority leader of the house
- 3 of representatives shall appoint the remaining commission member.
- 4 Before January 1, 2024, the senate majority leader shall appoint 1
- 5 of the commission members described in subsection (1)(f) and (g)
- 6 and the senate minority leader shall appoint the remaining
- 7 commission member. Before January 1, 2024, the speaker of the house
- 8 of representatives shall appoint 1 of the commission members
- 9 described in subsection (1)(h) and (i) and the minority leader of

- 15 (3) The speaker of the house of representatives, the minority

- 19 appointment under subsection (1)(d) to (k) is not made by January
- 20 1, 2024, the chairperson shall appoint a member meeting the
- 21 applicable qualifications under subsection (1)(d) to (k). If a
- 22 vacancy for 1 or more of the members under subsection (1)(d) to (k)
- 23 occurs, the vacancy must be filled in the same manner as the
- 24 original appointment not more than 30 days after it occurs. If the
- 25 vacancy is not filled within 30 days, the chairperson shall appoint
- 26 a member to the fill the vacancy. A member appointed to fill a
- 27 vacancy caused by a resignation or death must be appointed for the
- 28 balance of the unexpired term. Each member described in subsection
- 29 (1) (h) to (k) must attest either that the member affiliates with 1

- 1 of the 2 political parties with the largest representation in the
- 2 legislature, and if so, identify the political party with which the
- 3 member affiliates, or that the member does not affiliate with
- 4 either of the major political parties. Not less than 1 of the
- 5 appointments made under subsection (1) must be from a different
- 6 affiliation than the other appointments.
- 7 (4) Before January 1, 2024, the governor shall appoint, with
- 8 advice and consent of the senate, 1 member to the Michigan
- 9 sentencing commission who must serve as chairperson. The
- 10 chairperson must be appointed for a term of 4 years. The
- 11 chairperson shall serve as a nonvoting member of the commission.
- 12 The individual appointed as chairperson must have a professional
- 13 background in criminal law.
- 14 (5) Except as otherwise provided in this subsection, the
- 15 commission members must be appointed for terms of 4 years. The
- 16 members of the commission appointed under subsection (1)(a) and (b)
- 17 must be appointed for terms of 2 years. The members first serving
- 18 under subsection (1)(d), (e), (f), and (g) shall serve for 4 years.
- 19 The members first serving under subsection (1)(h), (i), (j), and
- 20 (k) shall serve for 3 years. The members first serving under
- 21 subsection (1)(c) and (l) shall serve for 2 years.
- 22 (6) Except as provided in subsection (3) for a member under
- 23 subsection (1)(d) to (k), a vacancy on the commission caused by the
- 24 expiration of a term or a resignation or death must be filled in
- 25 the same manner as the original appointment. A member appointed to
- 26 fill a vacancy caused by a resignation or death must be appointed
- 27 for the balance of the unexpired term.
- 28 (7) Except for the chairperson, a commission member must not
- 29 receive a salary for being a commission member but must be

- reimbursed for the member's reasonable, actual, and necessary
 expenses incurred in the performance of the member's duties as a
 commission member.
- 4 (8) The commission may establish subcommittees that may
 5 consist of individuals who are not members of the commission,
 6 including, but not limited to, experts in matters of interest to
 7 the commission. A subcommittee member, who is not a member of the
 8 commission, shall not vote on any recommendations made by the
 9 commission. A subcommittee member shall not receive a salary for
 10 the subcommittee member's service on a subcommittee.
- 11 (9) The commission's business must be conducted at public 12 meetings held in compliance with the open meetings act, 1976 PA 13 267, MCL 15.261 to 15.275.
- 14 (10) A quorum consists of a majority of the members of the 15 commission. All commission business must be conducted by not less 16 than a quorum.
- (11) A writing prepared, owned, used, in the possession of, or retained by the commission in the performance of an official function must be made available to the public in compliance with the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246.
- Enacting section 1. This amendatory act does not take effect unless **Senate** Bill No. **377** of the 102nd Legislature is enacted into law.
