Sec. 2. RICHFIELD; 77TH STREET UNDERPASS.

- Subdivision 1. Appropriation. \$5,000,000 is appropriated from the bond proceeds fund 2.5 to the commissioner of transportation for a grant to the city of Richfield for the extension 2.6 of 77th Street under marked Trunk Highway 77/Cedar Avenue project in the city of Richfield, 2.7 and is added to the appropriation in Laws 2015, First Special Session chapter 5, article 1, 2.8 section 10, subdivision 7, as amended by Laws 2017, First Special Session chapter 8, article 2.9 2, section 32. This appropriation is not available until the commissioner of management 2.10 and budget determines that at least \$13,800,000 has been committed from other sources to 2.11 complete the project. Contributions from other sources include other money spent on the 2.12 project before the effective date of this subdivision. 2.13
- Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond proceeds fund, the commissioner of management and budget shall sell and issue bonds of the state in an amount up to \$5,000,000 in the manner, upon the terms, and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI, sections 4 to 7.
