1.10	(1) maintains or permits a condition which unreasonably annoys, injures or endangers
1.11	the safety, health, morals, comfort, or repose of any considerable number of members of
1.12	the public; or
1.13	(2) except as provided in paragraph (b), interferes with, obstructs, or renders dangerous
1.14	for passage, any public highway or right-of-way, or waters used by the public; or
1.15	(3) is guilty of any other act or omission declared by law to be a public nuisance and for
1.16	which no sentence is specifically provided.
1.17	(b) It is a gross misdemeanor for a person to interfere with or obstruct traffic that is
1.18	entering, exiting, or on a freeway or entering, exiting, or on a public roadway within the
