1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. ST. PAUL; GREAT RIVER PASSAGE, RIVER LEARNING CENTER.
1.6	Subdivision 1. Appropriation. \$3,000,000 is appropriated from the bond proceeds fund
1.7	to the Metropolitan Council for a grant to the city of St. Paul for predesign and design of a
1.8	River Learning Center project and adjacent site development in Crosby Farms Regional
1.9	Park. The project will integrate environmental education, river access, and river and
1.10	nature-based recreation, along with increasing safe access to and awareness by the public
1.11	of the Mississippi River. The River Learning Center is an opportunity to build on the history
1.12	and interconnectedness to the river, create an authentic, signature destination that positions
1.13	the state nationally and internationally, improve the quality of life for residents and visitors,
