1.7	Section 1. Minnesota Statutes 2008, section 116L.666, subdivision 3, is amended to

1.9	Subd. 3. Membership on local workforce councils. In workforce service areas
1.10	representing only one home rule charter or statutory city or a county, the chief elected
1.11	official must appoint members to the council. In workforce service areas representing two
1.12	or more home rule charter or statutory cities or counties, the chief elected officials of the
1.13	home rule charter or statutory cities or counties must appoint members to the council, in
1.14	accordance with an agreement entered into by such units of general local government.
