4.17	Subd. 4. County administered grants. (a) To be eligible for a grant under this
4.18	subdivision, a business or nonprofit must, to the extent it is feasible for the county to
4.19	determine:
4.20	(1) have been impacted by an executive order related to the COVID-19 pandemic;
4.21	(2) be located in the county awarding the grant or on adjacent tribal lands; and
4.22	(3) be in good standing with the Department of Revenue as of November 1, 2020.
4.23	(b) Counties shall make grants to eligible businesses or nonprofits. Counties may contract
4.24	with a nonprofit to administer these grants.
4.25	(c) Individual grants shall be proportional to the size of the business or nonprofit and in

4.27	(d) Grant funds must be used by the eligible business or nonprofit for operations expenses
4.28	incurred during the COVID-19 pandemic.
4.29	(e) Any funds not distributed by a county by March 15, 2021, shall be returned to the
4.30	commissioner of management and budget for deposit in the state general fund by April 1,
