1.5	Section 1. PERMANENT SCHOOL FUND; DISTRIBUTION OF ENDOWMENT
1.6	FUND EARNINGS TASK FORCE.
1.7	Subdivision 1. Task force established. A task force of nine members is established to
1.8	examine the distribution of earnings from the permanent school fund endowment.
1.9	Subd. 2. Membership qualifications and appointments. (a) Appointed members of
1.10	the task force must have outstanding professional experience in at least one of the following
1.11	areas:
1.12	(1) institutional asset management;
1.13	(2) investment finance;
1.14	(3) trust administration;
1.15	(4) investment fund accounting;
1.16	(5) investment banking; or
1.17	(6) the practice of law in the areas of capital markets, securities funds, trusts, foundations,
