Subd. 3. Initial expenditure limitations. The amount that the county may grant or 3.4 expend for ballpark costs shall not exceed \$260,000,000. The amount of any grant for capital 3.5 improvement reserves shall not exceed \$1,000,000 annually, subject to the agreement under 3.6 section 473.759, subdivision 3, and to annual increases according to an inflation index 3.7 acceptable to the county.
