OFFICIAL STATUS

1.1 A bill for an act  
1.2 relating to capital investment; modifying the project description for the St. Cloud  
1.3 prison project; extending availability of an appropriation; amending Laws 2014,  
1.4 chapter 295, section 9; Laws 2017, First Special Session chapter 8, article 1, section  
1.5 19, subdivision 3.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Laws 2014, chapter 295, section 9, is amended to read:

1.8 Sec. 9. **CORRECTIONS** **\$ 18,000,000**

1.9 To the commissioner of administration to  
1.10 design, construct, furnish, and equip phase  
1.11 one of a new health services unit, a new  
1.12 service corridor and security station leading  
1.13 to the unit, and a mechanical building to serve  
1.14 the new health unit and associated utility  
1.15 infrastructure systems and site work; and to  
1.16 design phase two consisting of new intake,  
1.17 warehouse, and loading dock buildings  
1.18 associated utility infrastructure systems and  
1.19 sitework and all associated repurposing,  
1.20 including asbestos and hazardous materials  
1.21 abatement of interior spaces that were formally  
1.22 used for the occupancies being moved to the  
1.23 new phase one and two buildings at the  
1.24 Minnesota Correctional Facility in St. Cloud.

2.1 Any unspent portion of this appropriation not  
 2.2 needed to complete this work, upon written  
 2.3 notice to the commissioner of management  
 2.4 and budget, may be used for the purposes  
 2.5 described in Laws 2017, First Special Session  
 2.6 chapter 8, article 1, section 19, subdivision 3,  
 2.7 as amended in section 2, and notwithstanding  
 2.8 Minnesota Statutes, section 16A.642, is  
 2.9 available until December 31, 2020.
