AN ACT

To amend chapter 227, RSMo, by adding thereto six new sections relating to highway naming.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto six new sections, to be known as sections 227.447, 227.448, 227.449, 227.532, 227.533, and 227.535, to read as follows:

227.447. The portion of Interstate Highway 55 from its interchange with U.S. Highway 61 at exit 170 continuing north to its interchange with U.S. Highway 67 at exit 2 174B in Jefferson County shall be designated the "USMA Cadet Thomas M. Surdyke 3 Memorial Highway". The department of transportation shall erect and maintain 4 5 appropriate signs designating such highway with the costs to be paid by private donations. The portion of Highway 25 from one mile north of the Stoddard 227.448. County/Dunklin County line to one mile south of such county line shall be designated the 2 "Narvel Felts Highway". The department of transportation shall erect and maintain 3 appropriate signs designating such highway, with the costs to be paid by private donations. 4 227.449. The portion of State Highway 163 from the interchange with Interstate 70 continuing south to Loop 70 in Boone County shall be designated as "Sherman Brown Jr. 2 Memorial Highway". The department of transportation shall erect and maintain 3 appropriate signs designating such highway with the costs to be paid by private donations. 4 227.532. The portion of Missouri 249 from State Highway VV continuing north to Missouri 171 in Jasper County shall be designated as the "Edward F Dixon The Third 2 3 Memorial Highway". The department of transportation shall erect and maintain

227.533. The bridge on State Highway 100 crossing over Big Boeuf Creek in
Franklin County shall be designated the "Lyndon Ebker Memorial Bridge". The
department of transportation shall erect and maintain appropriate signs designating such
bridge, with the costs of such designation to be paid for by private donation.

227.535. The portion of State Highway 231 from the interchange with Interstate
255 north to River City Casino Boulevard in St. Louis City shall be designated the
"Veterans - Heroes Highway". The department of transportation shall erect and maintain
appropriate signs designating such highway, with costs to be paid for by private donations.
