AN ACT

To amend chapter 227, RSMo, by adding thereto seven new sections relating to infrastructure designations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto seven new

- 2 sections, to be known as sections 227.447, 227.448, 227.449, 227.532, 227.533,
- 3 227.535, and 1, to read as follows:

227.447. The portion of Interstate Highway 55 from its

- 2 interchange with U.S. Highway 61 at exit 170 continuing north to the
- 3 point at which U.S. Highway 61 overpasses Interstate Highway 55 in
- 4 Jefferson County shall be designated the "USMA Cadet Thomas M.
- 5 Surdyke Memorial Highway". The department of transportation shall
- 6 erect and maintain appropriate signs designating such highway, with
- 7 the costs to be paid by private donations.

227.448. The portion of Business 25 from Taylor Street continuing

- 2 north to Douglas Street through the city of Malden in Dunklin County
- 3 shall be designated the "Narvel Felts Highway". The department of
- 5 such highway, with the costs to be paid by private donations.

227.449. The portion of State Highway 163 from the interchange

- 2 with Interstate 70 continuing south to Loop 70 in Boone County shall
- 3 be designated as "Sherman Brown Jr. Memorial Highway". The
- 4 department of transportation shall erect and maintain appropriate
- 5 signs designating such highway, with the costs to be paid by private
- 6 donations.

227.532. The portion of Missouri 249 from State Highway VV

CCS SB 64

2 continuing north to Missouri 171 in Jasper County shall be designated

- 3 as the "Edward F. Dixon The Third Memorial Highway". The department
- 4 of transportation shall erect and maintain appropriate signs
- 5 designating such highway, with the costs of such designation to be paid
- 6 for by private donation.

227.533. The bridge on State Highway 100 crossing over Big

- 2 Boeuf Creek in Franklin County shall be designated the "Lyndon Ebker
- Memorial Bridge". The department of transportation shall erect and
- 4 maintain appropriate signs designating such bridge, with the costs of
- 5 such designation to be paid for by private donation.

227.535. The portion of State Highway 231 from the interchange

- 2 with Interstate 255 north to River City Casino Boulevard in St. Louis
- B City shall be designated the "Veterans Heroes Highway". The
- 4 department of transportation shall erect and maintain appropriate
- 5 signs designating such highway, with costs to be paid for by private
- 6 donations.

Section 1. The bridge on State Highway 99 crossing over Eleven

- 2 Point River in Thomasville in Oregon County shall be designated as the
- 3 "Roger "Dusty" Shaw Memorial Bridge". The department of
- 4 transportation shall erect and maintain signs designating such bridge,
- 5 with the cost of such designation to be paid for by private donations.
