Reported from the Committee on Seniors, Families and Children, February 1, 2018, with recommendation that the Senate Committee Substitute do pass. 5029S.03C ADRIANE D. CROUSE, Secretary.

AN ACT

To repeal section 195.070, RSMo, and to enact in lieu thereof two new sections relating to the disposal of unused controlled substances, with an emergency clause for a certain section.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 195.070, RSMo, is repealed and two new sections 2 enacted in lieu thereof, to be known as sections 195.070 and 195.265, to read as 3 follows:

195.070. 1. A physician, podiatrist, dentist, a registered optometrist certified to administer pharmaceutical agents as provided in section 336.220, or an assistant physician in accordance with section 334.037 or a physician assistant in accordance with section 334.747 in good faith and in the course of his or her professional practice only, may prescribe, administer, and dispense controlled substances or he or she may cause the same to be administered or dispensed by an individual as authorized by statute.

8 2. An advanced practice registered nurse, as defined in section 335.016, 9 but not a certified registered nurse anesthetist as defined in subdivision (8) of section 335.016, who holds a certificate of controlled substance prescriptive 10 authority from the board of nursing under section 335.019 and who is delegated 11 12the authority to prescribe controlled substances under a collaborative practice arrangement under section 334.104 may prescribe any controlled substances 13listed in Schedules III, IV, and V of section 195.017, and may have restricted 14 authority in Schedule II. Prescriptions for Schedule II medications prescribed by 15an advanced practice registered nurse who has a certificate of controlled 1617substance prescriptive authority are restricted to only those medications 18 containing hydrocodone. However, no such certified advanced practice registered

19 nurse shall prescribe controlled substance for his or her own self or
20 family. Schedule III narcotic controlled substance and Schedule II - hydrocodone
21 prescriptions shall be limited to a one hundred twenty-hour supply without refill.

3. A veterinarian, in good faith and in the course of the veterinarian's
professional practice only, and not for use by a human being, may prescribe,
administer, and dispense controlled substances and the veterinarian may cause
them to be administered by an assistant or orderly under his or her direction and
supervision.

274. A practitioner shall not accept any portion of a controlled substance 28unused by a patient, for any reason, if such practitioner did not originally dispense the drug. However, unused controlled substances may be 2930 accepted from ultimate consumers through collection receptacles, drug 31disposal boxes, and other means provided through drug take back 32 programs by a Drug Enforcement Agency-authorized collector in accordance with federal regulations, even if the authorized collector 33 did not originally dispense the drug. This subsection shall supercede 34 and preempt any local ordinances or regulations, including any 3536 ordinances or regulations enacted by any political subdivision of the state, regarding the disposal of unused controlled substances. 37

38 5. An individual practitioner shall not prescribe or dispense a controlled
39 substance for such practitioner's personal use except in a medical emergency.

195.265. By August 28, 2019, the department of health and senior
services shall develop an education and awareness program regarding
drug disposal, including controlled substances. The education and
awareness program may include, but not be limited to:

(1) A web-based resource that:

6 (a) Describes available drug disposal options including take 7 back, take back events, mailers, in-home disposal options that render 8 a product safe from misuse, or any other methods that comply with 9 state and federal laws and regulations, may reduce the availability of 10 unused controlled substances, and may minimize the potential 11 environmental impact of drug disposal;

(b) Provides a list of drug disposal take back sites, which may be
sorted and searched by name or location;

14 (c) Provides a list of take back events in the state, including the
15 date, time, and location information for each event; and

(d) Provides information for authorized collectors regarding
state and federal requirements to comply with the provisions of
subsection 4 of section 195.090; and

19 (2) Promotional activities designed to ensure consumer
20 awareness of proper storage and disposal of prescription drugs,
21 including controlled substances.

Section B. Because immediate action is necessary to allow for the safe disposal of unused pharmaceuticals, the repeal and reenactment of section 195.070 of this act is deemed necessary for the immediate preservation of the public health, welfare, peace, and safety, and is hereby declared to be an emergency act within the meaning of the constitution, and the repeal and reenactment of section 195.070 of this act shall be in full force and effect upon its passage and approval.
