AN ACT

To amend chapter 173, RSMo, by adding thereto one new section relating to free speech at public institutions of higher education.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 173, RSMo, is amended by adding thereto one new 2 section, to be known as section 173.1550, to read as follows:

173.1550. 1. The provisions of this section shall be known and cited as the "Campus Free Expression Act". Expressive activities protected under the provisions of this section include, but are not limited to, all forms of peaceful assembly, protests, speeches, distribution of literature, carrying signs, and circulating petitions.

- 2. The outdoor areas of campuses of public institutions of higher education in this state shall be deemed traditional public forums. Public institutions of higher education may maintain and enforce reasonable time, place, and manner restrictions in service of a compelling institutional interest only when such restrictions employ clear, published, content, and viewpoint-neutral criteria, and provide for ample alternative means of expression. Any such restrictions shall allow for members of the university community to spontaneously and contemporaneously assemble.
- 3. Any person who wishes to engage in expressive activity on campus shall be permitted to do so freely, as long as the person's conduct is not unlawful and does not materially and substantially disrupt the functioning of the institution.
- 4. Nothing in this section shall be interpreted as limiting the right of student expression elsewhere on campus.
- 21 5. The following persons may bring an action in a court of

22 competent jurisdiction to enjoin any violation of this section or to 23recover compensatory damages, reasonable court costs, and attorney 24fees:

- (1) The attorney general;
- 26 (2) Persons whose expressive rights were violated through the 27 violation of this section.
- 28 6. In an action brought under subsection 5 of this section, if the 29 court finds a violation, the court shall award the aggrieved persons no less than five hundred dollars for the initial violation, plus fifty dollars 30 for each day the violation remains ongoing. 31
- 7. A person shall be required to bring suit for violation of this section not later than one year after the day the cause of action 33 accrues. For purposes of calculating the one-year limitation period, 34each day that the violation persists, and each day that a policy in 3536 violation of this section remains in effect, shall constitute a new violation of this section and, therefore, a new day that the cause of action has accrued.
