BUTTREY 4 5 A BILL FOR AN ACT ENTITLED: "AN ACT EXEMPTING PULSE PROCESSING EQUIPMENT FROM 6 PROPERTY TAXATION; AMENDING SECTION 15-6-220, MCA; AND PROVIDING AN APPLICABILITY DATE 7 AND A TERMINATION DATE." 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA: 9 10 11 **Section 1.** Section 15-6-220, MCA, is amended to read: 12 "15-6-220. Agricultural processing facilities exemption -- canola -- malting barley -- industrial 13 **dairy -- ethanol.** (1) The following property is exempt from property taxation: 14 (a) machinery and equipment used in a canola seed oil processing facility; 15 (b) machinery and equipment used in a malting barley facility; 16 (c) personal property used by an industrial dairy or an industrial milk processor and dairy livestock used 17 by an industrial dairy; and 18 (d) all manufacturing machinery, fixtures, equipment, and tools used for the production of ethanol from 19 grain during the course of the construction of an ethanol manufacturing facility and for 10 years after completion 20 of construction of the manufacturing facility; and 21 (e) machinery and equipment used in a pulse processing facility. 22 (2) "Canola seed oil processing facility" means a facility that: 23 (a) extracts oil from canola seeds, refines the crude oil to produce edible oil, formulates and packages 24 the edible oil into food products, or engages in any one or more of those processes; and 25 (b) employs at least 15 employees in a full-time capacity. 26 (3) "Industrial dairy" means a large-scale dairy operation with 1,000 or more milking cows and includes 27 the dairy livestock and integral machinery and equipment that the dairy uses to produce milk and milk products 28 solely for export from the state, either directly by the dairy or after the milk or milk product has been further 29 processed by an industrial milk processor. After export, any unprocessed milk must be further processed into

other dairy products.

1	(4) "Industrial milk processor" means a facility and integral machinery used solely to process milk into
2	milk products for export from the state.
3	(5) "Malting barley facility" means a facility and integral machinery and equipment used principally to malt
4	malting barley and includes machinery and equipment to mix, blend, transport, transfer, or process the barley and
5	malt at the facility.
6	(6) "PULSE CROPS" MEANS DRY PEAS, LENTILS, CHICKPEAS, AND FAVA BEANS.
7	(6)(7) "Pulse processing facility" means a facility and integral machinery and equipment placed into
8	service after December 31, 2017, and used principally to process pulse crops. The term includes machinery and
9	equipment used to mix, split, transport WITHIN THE FACILITY, transfer, extract protein from, dry, or handle any pulse
0	crop."

2	NEW SECTION. Section 2. Applicability. [This act] applies to machinery and equipment placed into
3	service after December 31, 2017.
4	
5	NEW SECTION. Section 3. Termination. [This act] Terminates December 31, 2027.
