A BILL TO BE ENTITLED

AN ACT TO PROVIDE ADDITIONAL FLEXIBILITY TO CERTAIN LOCAL BOARDS OF EDUCATION IN ADOPTING THE SCHOOL CALENDAR.

SECTION 1. G.S. 115C-84.2(d) reads as rewritten:

6 Opening and Closing Dates. - Local boards of education shall determine the dates of "(d) 7 opening and closing the public schools under subdivision (a)(1) of this section. Except for 8 year-round schools, the opening date for students shall be no earlier than the Monday closest to 9 August 26, and the closing date for students shall be no later than the Friday closest to June 11. 10 On a showing of good cause, the State Board of Education may waive the requirement that the opening date for students be no earlier than the Monday closest to August 26 and may allow the 11 local board of education to set an opening date no earlier than the Monday closest to August 19, 12 13 to the extent that school calendars are able to provide sufficient days to accommodate anticipated makeup days due to school closings. A local board may revise the scheduled closing date if 14 necessary in order to comply with the minimum requirements for instructional days or 15 instructional time. For purposes of this subsection, the term "good cause" means that schools in 16 any local school administrative unit in a county have been closed eight days per year during any 17 four of the last 10 years because of severe weather conditions, energy shortages, power failures, 18 19 or other emergency situations.

20 Notwithstanding the required opening date under this subsection, a local board of education 21 may schedule its school opening date for any school in the local school administrative unit to 22 coincide with the opening date of a community college serving the city or county in which the 23 school unit is located.

The required opening and closing dates under this subsection shall not apply to any school that a local board designated as having a modified calendar for the 2003-2004 school year or to any school that was part of a planned program in the 2003-2004 school year for a system of modified calendar schools, so long as the school operates under a modified calendar."

28 SECTION 2. This act applies only to Elkin City Schools, Mount Airy City Schools,
29 Rockingham County Schools, Stokes County Schools, and Surry County Schools.

30 **SECTION 3.** This act is effective when it becomes law and applies beginning with 31 the 2019-2020 school year.
