General Assembly Of North Carolina

1 Duties of School Officials. – It shall be the duty of all school officials to carry out (d) 2 such instructions from the State Board of Education, and any school official failing to carry out 3 such instructions shall be guilty of a Class 3 misdemeanor: Provided, that the compulsory 4 attendance law herein prescribed shall not be in force in any local school administrative unit that 5 has a higher compulsory attendance feature than that provided herein." 6

SECTION 3. G.S. 115C-382.5 reads as rewritten:

7 "§ 115C-382.5. Student attendance recognition programs.

8 Local boards of education are encouraged to adopt a student attendance recognition program 9 within the local school administrative unit to promote student attendance in school and 10 participation in class as an integral part of academic achievement and the learning process. If the 11 local board of education adopts a student attendance recognition program, a student with an absence resulting from service as a legislative page or a Governor's page or because of an excused 12 13 absence identified in G.S. 115C-379(b)(2) shall be eligible for participation in the program and 14 the student's absence shall not be included as part of the student's record of attendance for the purposes of the program." 15

16 **SECTION 4.** This act is effective when it becomes law and applies beginning with 17 the 2019-2020 school year.
