18	North Carolina resident who is entitled to any benefits or rights under the laws of the United			
19	States by serving in and discharging honorably from the Armed Forces of the United States.			
20		ECTION 2. It is the intent of the General Assembly that the costs as		
21	-	Medicaid expansion to the population described under Section 1 of this act shall be paid entirely
