- 1 A BILL for an Act to amend and reenact subsection 7 of section 23-07.5-02, sections 65-01-02,
- 2 65-01-11, 65-01-15, 65-02-20, 65-02-21.1, 65-05-07, 65-05-08.1, and 65-05-08.3, subsections 5
- 3 and 12 of section 65-05-12.2, section 65-05-28, subsection 2 of section 65-05-29, section

4 65-05-30, subsection 3 of section 65-05-32, subsection 5 of section 65-05.1-01, subsection 6 of

5 section 65-05.1-02, and subsection 1 of section 65-07-03 of the North Dakota Century Code,

6 relating to the definition of allied health care professional and health care provider with respect

7 to workers' compensation claims and benefits.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9 SECTION 1. AMENDMENT. Subsection 7 of section 23-07.5-02 of the North Dakota

10 Century Code is amended and reenacted as follows:

- The exposed individual shall pay the expense of testing. However, if the exposure
 occurs at an employee's workplace, the worker's employer shall pay the expense of
- 13 testing unless otherwise provided by subdivision b of subsection <u>1011</u> of section
- 14 65-01-02. If the individual to be tested is convicted of a crime relating to the exposure
- 15 or the exposure occurred during an arrest or other contact with the exposed individual
- 16 in the course of that individual's official duties, a court may order the individual to be17 tested to pay for the testing.

18 SECTION 2. AMENDMENT. Section 65-01-02 of the North Dakota Century Code is

- 19 amended and reenacted as follows:
- 20 **65-01-02**. **Definitions**.
- 21 In this title:
- 1. "Acute care" means a short course of intensive diagnostic and therapeutic services
- provided immediately following a work injury with a rapid onset of pronouncedsymptoms.

- 2. "Adopted" or "adoption" refers only to a legal adoption effected prior to the time of the
 injury.
- 3. <u>"Allied health care professional" includes a health care provider, pharmacist,</u>
 audiologist, speech language pathologist, or naturopath or any recognized practitioner
 who provides skilled services pursuant to the prescription of, or under the supervision
 or direction of any of these individuals.
- 7 <u>4.</u> "Artificial members" includes a device that is a substitute for a natural part, organ,
 8 limb, or other part of the body. The term includes a prescriptive device that is an aid for
 9 a natural part, organ, limb, or other part of the body if the damage to the prescriptive
 10 device is accompanied by an injury to the body. A prescriptive device includes
 11 prescription eyeglasses, contact lenses, dental braces, and orthopedic braces.
- 4.5. "Artificial replacements" means mechanical aids, including braces, belts, casts, or
 crutches as may be reasonable and necessary due to compensable injury.
- 14 <u>5.6.</u> "Average weekly wage" means the weekly wages the employee was receiving from all
 15 employments for which coverage is required or otherwise secured at the date of first
 16 disability. The average weekly wage determined under this subsection must be
 17 rounded to the nearest dollar. If the employee's wages are not fixed by the week, they
 18 must be determined by using the first applicable formula from the schedule below:
- 19 For seasonal employment, during the first consecutive days of disability up to a. 20 twenty-eight days the average weekly wage is calculated pursuant to the first 21 applicable formula in subdivisions b through g, and after that are calculated as 22 one-fiftieth of the total wages from all occupations during the twelve months 23 preceding the date of first disability or during the tax year preceding the date of 24 first disability, or an average of the three tax years preceding the date of first 25 disability, whichever is highest and for which accurate, reliable, and complete 26 records are readily available.
- b. The "average weekly wage" of a self-employed employer is determined by the
 following formula: one fifty-second of the average annual net self-employed
 earnings reported the three preceding tax years or preceding fifty-two weeks
 whichever is higher if accurate, reliable, and complete records for those fifty-two
 weeks are readily available.

- c. Hourly or daily rate multiplied by number of hours or days worked per seven-day
 week.
- 3 d. Monthly rate multiplied by twelve months and divided by fifty-two weeks.
- 4 e. Biweekly rate divided by two.
- 5 f. The usual wage paid other employees engaged in similar occupations.
- 6 g. A wage reasonably and fairly approximating the weekly wage lost by the claimant
 7 during the period of disability.
- 8 6.7. "Average weekly wage in the state" means the determination made of the average
 9 weekly wage in the state by job service North Dakota on or before July first of each
 10 year, computed to the next highest dollar.
- 11 7.8. "Board" means the workforce safety and insurance board of directors.
- 8.9. "Brother" and "sister" include a stepbrother and a stepsister, a half brother and a half
 sister, and a brother and sister by adoption. The terms do not include a married
 brother or sister unless that person actually is dependent.
- 15 9.10. "Child", for determining eligibility for benefits under chapter 65-05, means a legitimate
- 16 child, a stepchild, adopted child, posthumous child, foster child, and acknowledged
 17 illegitimate child who is under eighteen years of age and resides with the employee; or
- 18 is under eighteen years of age and does not reside with the employee but a duty of
- 19 support is substantiated by an appropriate court order; or is between eighteen and
- 20 twenty-two years of age and enrolled as a full-time student in any accredited
- 21 educational institution and dependent upon the employee for support; or is eighteen
- years of age or over and is physically or mentally incapable of self-support and is
 actually dependent upon the employee for support. A child does not include a married
 child unless actually dependent on the employee as shown on the preceding year's
 income tax returns.
- 10.11. "Compensable injury" means an injury by accident arising out of and in the course of
 hazardous employment which must be established by medical evidence supported by
 objective medical findings.
- 29 a. The term includes:
- 30 (1) Disease caused by a hazard to which an employee is subjected in the
 31 course of employment. The disease must be incidental to the character of

1			the business and not independent of the relation of employer and employee.
2			Disease includes effects from radiation.
3		(2)	An injury to artificial members.
4		(3)	Injuries due to heart attack or other heart-related disease, stroke, and
5			physical injury caused by mental stimulus, but only when caused by the
6			employee's employment with reasonable medical certainty, and only when it
7			is determined with reasonable medical certainty that unusual stress is at
8			least fifty percent of the cause of the injury or disease as compared with all
9			other contributing causes combined. Unusual stress means stress greater
10			than the highest level of stress normally experienced or anticipated in that
11			position or line of work.
12		(4)	Injuries arising out of employer-required or supplied travel to and from a
13			remote jobsite or activities performed at the direction or under the control of
14			the employer.
15		(5)	An injury caused by the willful act of a third person directed against an
16			employee because of the employee's employment.
17		(6)	A mental or psychological condition caused by a physical injury, but only
18			when the physical injury is determined with reasonable medical certainty to
19			be at least fifty percent of the cause of the condition as compared with all
20			other contributing causes combined, and only when the condition did not
21			pre-exist the work injury.
22	b.	The	e term does not include:
23		(1)	Ordinary diseases of life to which the general public outside of employment
24			is exposed or preventive treatment for communicable diseases, except that
25			the organization may pay for preventive treatment for a health care provider
26			as defined in section 23-07.5-01, firefighter, peace officer, correctional
27			officer, court officer, law enforcement officer, emergency medical technician,
28			or an individual trained and authorized by law or rule to render emergency
29			medical assistance or treatment who is exposed to a bloodborne pathogen
30			as defined in section 23-07.5-01 occurring in the course of employment and
31			for exposure to rabies occurring in the course of employment.

1		(2)	A willfully self-inflicted injury, including suicide or attempted suicide, or an
2			injury caused by the employee's willful intention to injure or kill another.
3		(3)	Any injury caused by the use of intoxicants or the illegal use of controlled
4			substances.
5		(4)	An injury that arises out of an altercation in which the injured employee is an
6			aggressor. This paragraph does not apply to public safety employees,
7			including law enforcement officers or private security personnel who are
8			required to engage in altercations as part of their job duties if the altercation
9			arises out of the performance of those job duties.
10		(5)	An injury that arises out of an illegal act committed by the injured employee.
11		(6)	An injury that arises out of an employee's voluntary nonpaid participation in
12			any recreational activity, including athletic events, parties, and picnics, even
13			though the employer pays some or all of the cost of the activity.
14		(7)	Injuries attributable to a pre-existing injury, disease, or other condition,
15			including when the employment acts as a trigger to produce symptoms in
16			the pre-existing injury, disease, or other condition unless the employment
17			substantially accelerates its progression or substantially worsens its
18			severity. Pain is a symptom and may be considered in determining whether
19			there is a substantial acceleration or substantial worsening of a pre-existing
20			injury, disease, or other condition, but pain alone is not a substantial
21			acceleration or a substantial worsening.
22		(8)	A nonemployment injury that, although acting upon a prior compensable
23			injury, is an independent intervening cause of injury.
24		(9)	A latent or asymptomatic degenerative condition, caused in substantial part
25			by employment duties, which is triggered or made active by a subsequent
26			injury.
27		(10)	A mental injury arising from mental stimulus.
28	11.<u>12.</u>	"Date of	first disability" means the first date the employee was unable to work because
29		of a com	pensable injury.
30	12.<u>13.</u>	"Date of	maximum medical improvement" or "date of maximum medical recovery"
31		means th	he date after which further recovery from, or lasting improvement to, an injury

3 32. a. "Wages" means:

- An employee's remuneration from all employment reportable to the internal revenue service as earned income for federal income tax purposes.
- (2) For members of the national guard who sustain a compensable injury while on state active duty, "wages" includes income from federal employment and may be included in determining the average weekly wage.
- 9 (3) For purposes of chapter 65-04 only, "wages" means all gross earnings of all 10 employees. The term includes all pretax deductions for amounts allocated 11 by the employee for deferred compensation, medical reimbursement, 12 retirement, or any similar program, but may not include dismissal or 13 severance pay.
- b. The organization may consider postinjury wages for which coverage was not
 required or otherwise secured in North Dakota for purposes of determining
 appropriate vocational rehabilitation options or entitlement to disability benefits
 under this title.

SECTION 3. AMENDMENT. Section 65-01-11 of the North Dakota Century Code is
 amended and reenacted as follows:

20 **65-01-11.** Burden of proof in compensation matters - Death certificate.

21 If the organization or an employer claims that an employee is not entitled to the benefits of 22 the North Dakota workforce safety and insurance law because the employee's injury was 23 caused by the employee's willful intention to cause self-injury, or to injure another, or by reason 24 of the voluntary impairment caused by use of alcohol or illegal use of a controlled substance by 25 the employee, the burden of proving the exemption or forfeiture is uponon the organization or 26 uponon the person alleging the same; however, an alcohol concentration level at or above the 27 limit set by the United States secretary of transportation in the Code of Federal Regulations in 28 effect on August 1, 2011, or a level of an illegally used controlled substance sufficient to cause 29 impairment found by a test conducted by a physician, gualified technician, chemist, or 30 registered nurse at or above the cutoff level in the Code of Federal Regulations in effect on 31 August 1, 2011, creates a rebuttable presumption that the injury was due to impairment caused

1 by the use of alcohol or the illegal use of a controlled substance. An employer who has a 2 mandatory drug alcohol testing policy for work accidents, or an employer or a doctorhealth care. 3 provider who has reasonable grounds to suspect an employee's alleged work injury was caused 4 by the employee's voluntary impairment caused by use of alcohol or illegal use of a controlled 5 substance may request that the employee undergo testing to determine if the employee had 6 alcohol or the controlled substance in the employee's system at levels greater than the limit set 7 by the United States department of transportation at the time of the injury. If an employee 8 refuses to submit to a reasonable request to undergo a test to determine if the employee was 9 impaired or if an employee refuses to submit to a test for drugs or alcohol after a work accident 10 as mandated by company policy, the employee forfeits all entitlement to workforce safety and 11 insurance benefits arising out of that injury. Any claimant against the fund, however, has the 12 burden of proving by a preponderance of the evidence that the claimant is entitled to benefits. If 13 a claim for death benefits is filed, the official death certificate must be considered as evidence of 14 death and may not be used to establish the cause of death.

SECTION 4. AMENDMENT. Section 65-01-15 of the North Dakota Century Code is
 amended and reenacted as follows:

17 **65-01-15.** Yearly documentation required for firefighter and law enforcement officer.

Except for benefits for an exposure to a bloodborne pathogen as defined by section
23-07.5-01 occurring in the course of employment, a full-time paid firefighter or law enforcement
officer who uses tobacco is not eligible for the benefits provided under section 65-01-15.1,

21 unless the full-time paid firefighter or law enforcement officer provides yearly documentation

22 from a physicianhealth care provider which indicates that the full-time paid firefighter or law

23 enforcement officer has not used tobacco for the preceding two years.

SECTION 5. AMENDMENT. Section 65-02-20 of the North Dakota Century Code is
 amended and reenacted as follows:

26 **65-02-20. Organization to establish managed care program.**

The organization shall establish a managed care program, including utilization review and bill review, to effect the best medical solution for an injured employee in a cost-effective manner upon a finding by the organization that the employee suffered a compensable injury. The program shall operate according to guidelines adopted by the organization and shall provide for medical management of claims within the bounds of workforce safety and insurance law.

1 Information compiled and analysis performed pursuant to a managed care program which relate 2 to patterns of treatment, cost, or outcomes by health care providers and allied health care_ 3 professionals are confidential and are not open to public inspection to the extent the information 4 and analysis identify a specific health care provider or allied health care professional, except to 5 the specific health care provider, allied health care professional, organization employees, or 6 persons rendering assistance to the organization in the administration of this title. If an 7 employee, employer, or medical providerallied health care professional disputes a managed 8 care decision, the employee, employer, or medical providerallied health care professional shall 9 request binding dispute resolution on the decision. The organization shall make rules providing 10 for the procedures for dispute resolution. Dispute resolution under this section is not subject to 11 chapter 28-32 or section 65-01-16. A dispute resolution decision under this section requested by 12 a medical provideran allied health care professional concerning payment for medical treatment 13 already provided or a request for diagnostic tests or treatment is not reviewable by any court. A 14 dispute resolution decision under this section requested by an employee is reviewable by a 15 court only if medical treatment has been denied to the employee. A dispute resolution decision 16 under this section requested by an employer is reviewable by a court only if medical treatment 17 is awarded to the employee. The dispute resolution decision may be reversed only if the court 18 finds that there has been an abuse of discretion in the dispute resolution process. Any person 19 providing binding dispute resolution services under this section is exempt from civil liability 20 relating to the binding dispute resolution process and decision.

SECTION 6. AMENDMENT. Section 65-02-21.1 of the North Dakota Century Code is
 amended and reenacted as follows:

65-02-21.1. Licensure required for psychologists and physicians performing
 utilization review.

25 Psychologists making utilization review determinations under sections 65-02-20 and

- 26 65-02-21 shall have current licenses from the state board of psychologist examiners.
- 27 Physicians<u>Health care providers</u> making utilization review determinations under sections
- 28 65-02-20 and 65-02-21 shall have current licenses from the North Dakota board of-
- 29 medicineappropriate North Dakota licensing board. This requirement does not apply to
- 30 psychologists or physicianshealth care providers conducting independent medical examinations
- 31 or independent medical reviews under section 65-05-28.

2	amended and reenacted as follows:			
3	65-05-07. Injured employee given medical and hospital service required - Furnished

5	The	fund shall furnish to an injured employee reasonable and appropriate medical, surgical,		
6	and hos	pital service and supplies necessary to treat a compensable injury. The fund may
