- 4 as the Aging and Disability Resource Center Demonstration Project Act.
- 5 Sec. 2. Section 68-1113, Revised Statutes Cumulative Supplement,
- 6 2016, is amended to read:
- 7 68-1113 The purpose of the Aging and Disability Resource Center
- 8 Demonstration Project Act is to evaluate the feasibility of establishing
- 9 aging and disability resource centers statewide to provide information
- 10 about long-term care services and support available in the home and
- 11 community for older Nebraskans or persons with disabilities, family
- 12 caregivers, and persons who request information or assistance on behalf
- 13 of others and to assist eligible individuals to access the most
- 14 appropriate public and private resources to meet their long-term care
- 15 needs.
- 16 It is the intent of the Legislature that aging and disability
- 17 resource centers serve as an ongoing component of Nebraska's long-term
- 18 care continuum and that aging and disability resource center sites
- 19 coordinate and establish contractual provider partnerships as necessary
- 20 with organizations specializing in serving aging persons and persons with
- 21 <u>disabilities to provide the services described in the act.</u>

- 25 Demonstration Project Act:
- 26 (1) Aging and disability resource center means a community-based
- 27 entity established to provide information about long-term care services
- 28 and support and to facilitate access to options counseling to assist
- 29 eligible individuals and their representatives in identifying the most
- 30 appropriate services to meet their long-term care needs;
- 31 (2) Area agency on aging has the meaning found in section 81-2208;

- 9 (5) Eligible individual means a person who has lost, never acquired,
- 10 or has one or more conditions that affect his or her ability to perform
- 11 basic activities of daily living that are necessary to live
- 12 independently;
- 13 (6) Options counseling means a service that assists an eligible
- 14 individual in need of long-term care and his or her representatives to
- 15 make informed choices about the services and settings which best meet his
- 16 or her long-term care needs and that uses uniform <u>data and information</u>
- 17 collection assessments and encourages the widest possible use of
- 18 community-based options to allow an eligible individual to live as
- 19 independently as possible in the setting of his or her choice;
- 20 (7) Representative means a person designated as a legal guardian,
- 21 designated by a power of attorney or a health care power of attorney, or
- 22 chosen by law, by a court, or by an eligible individual seeking services,
- 23 but use of the term representative shall not be construed to disqualify
- 24 an individual who retains all legal and personal autonomy;
- 25 (8) Uniform assessment means a single standardized tool used to
- 26 assess a defined population at a specific time; and
- 27 (9) University Center for Excellence in Developmental Disability
- 28 Education, Research and Service means the federally designated University
- 29 Center for Excellence in Developmental Disability Education, Research and
- 30 Service of the Munroe-Meyer Institute at the University of Nebraska

- 6 <u>act.</u> The department shall award <u>funding</u> grants for three aging and
- 7 disability resource centers. The department shall pursue federal matching
- 8 funds as applicable and allocate such funds to the aging and disability
- 9 resource centers center demonstration projects. The department shall
- 10 adopt criteria for evaluating proposals to operate an aging and
- 11 disability resource center demonstration project based on the
- 12 requirements in section 68-1116 and release a request for proposals
- 13 within sixty days after August 30, 2015.

- 17 demonstration projects shall be established to evaluate the feasibility

- 19 means of promoting appropriate, effective, and efficient use of long-term
- 20 care resources. The aging and disability resource center demonstration
- 21 projects shall operate through June 30, 2018.
- 22 (2) Each aging and disability resource center demonstration project
- 23 shall provide one or more of the following services:
- (a) (1) Comprehensive information on the full range of available
- 25 public and private long-term care programs, options, financing, service
- 26 providers, and resources within a community, including information on the
- 27 availability of integrated long-term care;
- 28 (b) Options counseling;
- 29 (c) (2) Assistance in accessing and applying for public benefits
- 30 programs;

- 6 that an eligible individual is able to find the services and support that
- 7 are most appropriate to his or her need;
- 8 (g) (7) Mobility management to promote the appropriate use of public
- 9 transportation services by a person who does not own or is unable to

- 11 (h) (8) A home care provider registry that will provide a person who
- 12 needs home care with the names of home care providers and information
- 13 about his or her rights and responsibilities as a home care consumer.

- 17 for proposals under section 68-1115, an area agency on aging shall

- 19 <u>organizations that specialize in serving</u> , after consultation with a
- 20 collaboration of organizations that serve aging persons and persons with
- 21 congenital and acquired disabilities to provide services as described in
- 22 <u>subsection (2) of section 68-116</u>, including, but not limited to, centers
- 23 for independent living and the University Center for Excellence in
- 24 Developmental Disability Education, Research and Service, for the purpose
- 25 of developing an aging and disability resource center plan. After

- 3 demonstration project. The proposal shall be developed in consultation
- 4 with eligible individuals and their representatives. The plan proposal
- 5 shall indicate how resources will be utilized by the partnership and
- 6 collaborating organizations to fulfill the responsibilities of an aging
- 7 and disability resource center demonstration project.
- 8 (2) Two or more area agencies on aging <u>and their partner lead</u>
- 9 organizations may develop a joint proposal to establish an aging and
- 10 disability resource center plan demonstration project to serve all or a
- 11 portion of their planning-and-service areas. A joint <u>plan</u> proposal shall
- 12 provide information on how the services described in section 68-1116 will
- 13 be provided in the counties to be served by the aging and disability
- 14 resource center—demonstration project described in the joint proposal.

- 6 purpose of establishing and operating aging and disability resource
- 7 centers, and (3) other funds as available.
