- to amend section 60-4,112, Reissue Revised Statutes of Nebraska, and
- 3 section 60-462, Revised Statutes Supplement, 2023; to provide for
- 4 the issuance of veteran, honorary, and distinctive licenses; to
- 5 harmonize provisions; and to repeal the original sections.

- 7 60-4,112 Sections 60-4,114.01 and 60-4,118.01 to 60-4,130.05 and
- section 3 of this act shall apply to the operation of any motor vehicle 8
- 9 except a commercial motor vehicle.
- 10 (1)(a) This section shall not be interpreted as affecting
- the rights and privileges of a person holding a veteran, honorary, or 11
- 12 distinctive license.
- (b) Nothing in this section shall be construed so as to authorize 13
- the department to impose any charge or fee of any type for the issuance 14
- or renewal of a veteran, honorary, or distinctive license. 15
- (c) The department may adopt and promulgate rules and regulations on 16
- 17 types and classes of vehicles that may be operated by the holder of a
- veteran, honorary, or distinctive license. 18
- (2) The director shall adopt and promulgate rules and regulations 19
- prescribing the proof required by an applicant for a veteran, honorary, 20
- or distinctive license. 21
- (3)(a) The contents of a veteran, honorary, or distinctive license 22
- shall be the same as for any other operator's or driver's license. 23
- (b) Each veteran, honorary, and distinctive license shall be 24
- 25 permanently issued and shall not be subject to any fees.
- (c)(i) Except as provided in subdivision (2)(c)(ii) of this section, 26
- each veteran, honorary, and distinctive license shall be valid until the 27
- tenth birthday of the license holder after the date of issuance of the 28
- license. 29
- (ii) Each veteran, honorary, and distinctive license requires annual 30
- renewal on and after the sixty-fifth birthday of the license holder to 31

- 1 remain a valid operator's or driver's license.
- 2 (4) A veteran license may be issued to:
- 3 (a) Any veteran who is a resident of this state at the time of
- 4 application for the license, who served in the active military, naval, or
- 5 <u>air service</u>, and who was discharged or released from such service under
- 6 conditions other than dishonorable;
- 7 <u>(b) Any member or former member of the Nebraska National Guard or</u>
- 8 <u>reserve forces who served on active duty or who has twenty or more years</u>
- 9 of creditable service in the Nebraska National Guard or reserve forces;
- 10 and
- 11 (c) Any veteran who is a United States citizen or resident of this
- 12 <u>state at the time of application for the license and who served on active</u>
- 13 duty in the armed forces of an ally of the United States during wartime
- 14 or any conflict when personnel were committed by the President of the
- 15 United States, whether or not such veteran was assigned to a unit or
- 16 division which directly participated in such war or conflict and who was
- 17 discharged or separated under honorable conditions.
- 18 (5) An honorary license may be issued to:
- 19 (a) A resident of this state who is the surviving spouse of a
- 20 <u>veteran as described in subdivision (4)(a) of this section. Such license</u>
- 21 shall be valid only as long as the surviving spouse remains unmarried; or
- 22 (b) A resident of this state who is the spouse of a veteran who
- 23 would be qualified to receive a veteran license but who is disabled to
- 24 the extent that the veteran cannot operate a motor vehicle.
- 25 (6) A distinctive license may be issued to any member of the
- 26 Nebraska National Guard in good standing who has completed at least one
- 27 <u>year of satisfactory service. The department may cancel the distinctive</u>
- 28 license of any person upon receipt of written notice from the Adjutant
- 29 General that the person is no longer a member of the Nebraska National
- 30 <u>Guard in good standing. The Adjutant General shall notify the department</u>
- 31 within thirty days after such occurrence.
