# **LEGISLATIVE BILL 1322**

Introduced by Vargas, 7; Conrad, 46.

Read first time January 17, 2024

#### Committee:

- 1 A BILL FOR AN ACT relating to schools; to require that school counselors
- 2 spend a certain percentage of such counselor's time during normal
- 3 school hours in the direct counseling of students as prescribed.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) For purposes of this section:
- 2 (a) Appraisal and advisement means the act of assisting students in
- 3 the exploration of such student's abilities, interests, skills, and
- 4 achievements to make decisions and develop immediate and long-range goals
- 5 and plans;
- 6 (b) Consultation, collaboration, and referrals means (i) the act of
- 7 providing to and receiving from individuals or groups of individuals
- 8 information and counsel in support of a student's needs, (ii) working
- 9 with parents, teachers, administrators, school staff, and community
- 10 stakeholders to promote achievement for a specific student or to promote
- 11 systemic change to address the needs of groups of students, such as
- 12 <u>underserved or underrepresented groups of students in the school, and</u>
- 13 (iii) referring students to outside providers and resources as necessary;
- 14 (c) Crisis counseling means the act of providing counseling to
- 15 <u>individual students or small groups of students to help such students</u>
- 16 navigate critical situations, such as emergencies and crises;
- 17 (d) Direct counseling includes (i) school counseling curriculum,
- 18 <u>lessons</u>, and activities, (ii) individual counseling, (iii) small group
- 19 counseling, (iv) crisis counseling, (v) appraisal and advisement, and
- 20 (vi) consultation, collaboration, and referrals. Direct counseling does
- 21 not include program planning and school support;
- 22 (e) Fair-share responsibilities includes coordinating and
- 23 administering testing, supervising lunch, supervising recess, serving as
- 24 a substitute teacher, and performing other administrative duties;
- 25 (f) Individual counseling means the act of providing developmentally
- 26 appropriate, goal-focused, and brief counseling sessions to individual
- 27 <u>students to address issues related to mental health and wellness, social</u>
- 28 and emotional development, academic achievement, and college and career
- 29 <u>readiness;</u>
- 30 (g) Program planning and school support means the act of defining,
- 31 planning, managing, and assessing school counseling activities and

- 1 contributing to fair-share responsibilities provided by other educators
- 2 at the school. Program planning and school support includes activities
- 3 such as reviewing data, creating annual student outcome goals, creating
- 4 action plans and results reports, holding annual administrative
- 5 conferences, creating annual and weekly calendars, and facilitating
- 6 school counseling sessions;
- 7 (h) School counseling curriculum, lessons, and activities means the
- 8 act of providing data-informed lessons or activities at the classroom
- 9 level on a schoolwide basis to provide students with the knowledge,
- 10 attitudes, and skills appropriate for such student's developmental
- 11 <u>levels; and</u>
- 12 <u>(i) Small group counseling means the act of providing counseling to</u>
- 13 <u>small groups of students with similar developmental or situational</u>
- 14 <u>challenges</u> with the goal of improving achievement, attendance, mental
- 15 health or wellness, or behavioral outcomes.
- 16 (2) Beginning with the 2025-26 school year, each school counselor
- 17 employed by a school board in a public elementary, middle, or high school
- 18 shall spend at least eighty percent of such counselor's time during
- 19 normal school hours in the direct counseling of students and may spend up
- 20 to twenty percent of such counselor's time during school hours on program
- 21 planning and school support.
- 22 (3) Each school board shall adopt a policy consistent with this
- 23 <u>section</u>.
