2	23-2525, 23-2531, 23-2541, 29-401, 48-215, 48-628.13, 48-1101,
3	48-1104, 48-1105, 48-1106, 48-1107, 48-1111, 48-1113, 48-1115,
4	48-1117, 48-1119, 48-1122, 48-1124, and 49-801, Reissue Revised
5	Statutes of Nebraska; to prohibit discrimination based upon sexual
6	orientation and gender identity as prescribed; to define terms; to
7	harmonize provisions; and to repeal the original sections.
8	Be it enacted by the people of the State of Nebraska,

Section 1. Section 18-1724, Reissue Revised Statutes of Nebraska, is
 amended to read:

3 18-1724 Notwithstanding any other provision of law, all cities and villages in this state shall have the power by ordinance to define, 4 5 regulate, suppress, and prevent discrimination on the basis of race, color, creed, religion, ancestry, sex, marital status, national origin, 6 sexual orientation, gender identity, familial status as defined in 7 section 20-311, disability as defined in section 20-308.01, or age in 8 9 employment, public accommodation, and housing and may provide for the enforcement of such ordinances by providing appropriate penalties for the 10 violation thereof. It shall not be an unlawful employment practice to 11 refuse employment based on a policy of not employing both spouses if such 12 13 policy is equally applied to both sexes.

14 Sec. 2. Section 23-2525, Reissue Revised Statutes of Nebraska, is 15 amended to read:

16 23-2525 The county personnel officer shall, with the assistance of 17 two advisory groups, one of classified employees and one of department heads, prepare and submit to the personnel policy board proposed 18 19 personnel rules and regulations for the classified service. He or she shall give reasonable notice thereof to the heads of all agencies, 20 departments, county employee associations, and institutions affected 21 thereby, and they shall be given an opportunity, upon request, to appear 22 23 before the board and present their views thereon. The personnel policy 24 board shall submit the rules and regulations for adoption or amendment 25 and adoption by resolution of the board of county commissioners. Amendments thereto shall be made in the same manner. The rules and 26 regulations shall provide: 27

(1) For a single integrated classification plan covering all
positions in the county service except those expressly exempt from the
County Civil Service Act, which shall group all positions into defined
classes containing a descriptive class title and a code identifying each

1 class, and which shall be based on similarity of duties performed and 2 responsibilities assumed, so that the same qualifications may reasonably 3 be required and the same schedule of pay may be equitably applied to all positions in the same class. After the classification plan has been 4 approved by the personnel policy board, the county personnel officer 5 shall be responsible for the administration and maintenance of the plan 6 and for the allocation of each classified position. Any employee affected 7 8 by the allocation of a position to a class shall, upon request, be given 9 a reasonable opportunity to be heard thereon by the personnel policy board who shall issue an advisory opinion to the personnel officer; 10

(2) For a compensation plan for all employees in the classified 11 service, comprising salary schedules, hours of work, premium payments, 12 special allowances, and fringe benefits, considering the amount of money 13 14 available, the prevailing rates of pay in government and private employment, the cost of living, the level of each class of position in 15 16 the classification plan, and other relevant factors. Initial, intervening, and maximum rates of pay for each class shall be established 17 to provide for steps in salary advancement without change of duty in 18 19 recognition of demonstrated quality and length of service. The compensation plan and amendments thereto shall be adopted in the manner 20 prescribed for rules and regulations and shall in no way limit the 21 authority of the board of county commissioners relative to appropriations 22 for salary and wage expenditures; 23

24 (3) For open competitive examinations to test the relative fitness of applicants for the respective positions. Competitive examination shall 25 not be required for transferred employees transferring from positions in 26 the state or a political subdivision to positions in the county pursuant 27 28 to a merger of services or transferred employees transferring from positions in the state or a political subdivision to positions in the 29 county due to the assumption of functions of the state or a political 30 subdivision by the county. The rules and regulations shall provide for 31

the public announcement of the holding of examinations and shall 1 2 authorize the personnel officer to prescribe examination procedures and to place the names of successful candidates on eligible lists in 3 4 accordance with their respective ratings. Examinations may be assembled or unassembled and may include various job-related examining techniques, 5 such as rating training and experience, written tests, oral interviews, 6 7 recognition of professional licensing, performance tests, investigations, and any other measures of ability to perform the duties of the position. 8 9 Examinations shall be scored objectively and employment registers shall be established in the order of final score. Certification of eligibility 10 for appointment to vacancies shall be in accordance with a formula which 11 limits selection by the hiring department from among the highest ranking 12 13 available and eligible candidates, but which also permits selective 14 certification under appropriate conditions as prescribed in the rules and 15 regulations;

16 (4) For promotions which shall give appropriate consideration to
17 examinations and to record of performance, seniority, and conduct.
18 Vacancies shall be filled by promotion whenever practicable and in the
19 best interest of the service, and preference may be given to employees
20 within the department in which the vacancy occurs;

(5) For the rejection of candidates who fail to comply with reasonable requirements of the personnel officer in regard to such factors as physical conditions, training, and experience or who have been guilty of infamous or disgraceful conduct, who are addicted to alcohol or narcotics, or who have attempted any deception or fraud in connection with an examination;

27 (6) For prohibiting Prohibiting disqualification of any person from 28 taking an examination, from promotion, or from holding a position because 29 of race; τ sex, unless it constitutes a bona fide occupational 30 qualification; τ or national origin; τ physical disabilities; τ age; τ 31 <u>sexual orientation; gender identity; political or religious opinions or</u>

1 affiliations; τ or other factors which have no bearing upon the 2 individual's fitness to hold the position;

3 (7) For a period of probation not to exceed one year before appointment or promotion may be made complete, and during which period a 4 probationer may be separated from his or her position without the right 5 of appeal or hearing except as provided in section 23-2531. After a 6 7 probationer has been separated, he or she may again be placed on the eligible list at the discretion of the personnel officer. The rules shall 8 9 provide that a probationer shall be dropped from the payroll at the expiration of his or her probationary period if, within ten days prior 10 thereto, the appointing authority has notified the personnel officer in 11 writing that the services of the employee have been unsatisfactory; 12

(8) When an employee has been promoted but fails to satisfactorily perform the duties of the new position during the probationary period, he or she shall be returned to a position comparable to that held immediately prior to promotion at the current salary of such position;

17 (9) For temporary or seasonal appointments of limited terms of not18 to exceed one year;

19 (10) For part-time appointment where the employee accrues benefits
20 of full-time employment on a basis proportional to the time worked;

(11) For emergency employment for not more than thirty days with or without examination, with the consent of the county personnel officer and department head;

(12) For provisional employment without competitive examination when
there is no appropriate eligible list available. No such provisional
employment shall continue longer than six months, nor shall successive
provisional appointments be allowed;

(13) For transfer from a position in one department to a similar
position in another department involving similar qualifications, duties,
responsibilities, and salary ranges;

31 (14) For the transfer of employees of the state or a political

1 subdivision to the county pursuant to a merger of services or due to the 2 assumption of functions of the state or a political subdivision by the 3 county;

4 (15) For layoff by reason of lack of funds or work or abolition of 5 the position, or material change in duties or organization, for the 6 layoff of nontenured employees first, and for reemployment of permanent 7 employees so laid off, giving consideration in both layoff and 8 reemployment to performance record and seniority in service;

9 (16) For establishment of a plan for resolving employee grievances10 and complaints;

11 (17) For hours of work, holidays, and attendance regulations in the 12 various classes of positions in the classified service, and for annual, 13 sick, and special leaves of absence, with or without pay, or at reduced 14 pay;

(18) For the development of employee morale, safety, and trainingprograms;

18 reduce, demote, or dismiss an employee for misconduct, inefficiency,
19 incompetence, insubordination, malfeasance, or other unfitness to render
20 effective service and for the investigation and public hearing of appeals

(20) For granting of leave without pay to a permanent employee to
accept a position in the unclassified service, and for his or her return
to a position comparable to that formerly held in the classified service
at the conclusion of such service;

(21) For regulation covering political activity of employees in the
 classified service; and

(22) For other regulations not inconsistent with the County Civil
Service Act and which may be necessary for its effective implementation.

30 Sec. 3. Section 23-2531, Reissue Revised Statutes of Nebraska, is 31 amended to read:

1 23-2531 (1) Discrimination against any person in recruitment, 2 examination, appointment, training, promotion, retention, discipline, or any other aspect of personnel administration because of political or 3 4 religious opinions or affiliations or because of race, national origin, 5 sexual orientation, gender identity, or other nonmerit factors shall be prohibited. Discrimination on the basis of age or sex or physical 6 7 disability shall be prohibited unless specific age, sex, or physical requirements constitute a bona fide occupational qualification necessary 8 to proper and efficient administration. The rules and regulations shall 9 10 provide for appeals in cases of alleged discrimination to the personnel policy board whose determination shall be binding upon a finding of 11 discrimination. 12

13 (2) No person shall make any false statement, certificate, mark, 14 rating, or report with regard to any test, certification, or appointment 15 made under the County Civil Service Act or in any manner commit or 16 attempt to commit any fraud preventing the impartial execution of the act 17 and the rules and regulations promulgated pursuant to the act.

(3) No person shall, directly or indirectly, give, render, pay,
offer, solicit, or accept any money, service, or other valuable
consideration for or on account of any appointment, proposed appointment,
promotion, or proposed promotion to, or any advantage in, a position in
the classified service.

(4) No employee of the personnel office, examiner, or other person shall defeat, deceive, or obstruct any person in his or her right to examination, eligibility, certification, or appointment under the act, or furnish to any person any special or secret information for the purpose of affecting the rights or prospects of any persons with respect to employment in the classified service.

Sec. 4. Section 23-2541, Reissue Revised Statutes of Nebraska, isamended to read:

31 23-2541 The personnel policy board, if created, shall, with the

assistance of two advisory groups, one of classified employees and one of 1 2 department heads, adopt proposed personnel rules and regulations for the classified service and provide reasonable notice of proposed rules and 3 4 regulations to the heads of all agencies, departments, county employee associations, and institutions affected thereby. Any person affected by 5 such rules and regulations shall be given an opportunity, upon request, 6 to appear before the personnel policy board and present his or her views 7 on the rules and regulations. The personnel policy board shall submit 8 proposed rules and regulations or amendments for adoption by the county 9 board. The county board may consider and adopt only personnel rules and 10 regulations or amendments proposed by the personnel policy board and may 11 not repeal or revoke a rule or regulation except upon the recommendation 12 13 of the personnel policy board.

The rules and regulations or amendments may provide:

(1) For a single integrated classification plan covering all 15 positions in the county service except those expressly exempt from 16 sections 23-2534 to 23-2544, which shall (a) group all positions into 17 defined classes containing a descriptive class title and a code 18 identifying each class and (b) be based on similarity of duties performed 19 and responsibilities assumed, so that the same qualifications may 20 reasonably be required and the same schedule of pay may be equitably 21 applied to all positions in the same class. After the classification plan 22 has been approved by the personnel policy board, the county personnel 23 24 officer shall be responsible for the administration and maintenance of 25 the plan and for the allocation of each classified position. Any employee affected by the allocation of a position to a class shall, upon request, 26 be given a reasonable opportunity to be heard on such allocation by the 27 personnel policy board which shall issue an advisory opinion to the 28 county personnel officer; 29

30 (2) For a compensation plan for all employees in the classified31 service, comprising salary schedules, attendance regulations, premium

The compensation 4 5 plan and amendments to such plan shall be adopted in the manner prescribed for rules and regulations and shall in no way limit the 6 authority of the county board relative to appropriations for salary and 7 wage expenditures; 8

9 (3) For open competitive examinations to test the relative fitness of applicants for the respective positions. The rules and regulations 10 shall provide for the public announcement of the holding of examinations 11 and shall authorize the county personnel officer to prescribe examination 12 13 procedures and to place the names of successful candidates on eligible 14 lists in accordance with their respective ratings. 6 (6) For prohibiting disgualification of any person from (a) taking an examination, (b) promotion, or (c) holding a position, solely because 7 8 of race, sex, national origin, physical disabilities, age, sexual orientation, gender identity, political or 9 religious opinions or 10 affiliations, or other factors which have no bearing upon the individual's fitness to hold the position; 11

(7) For a period of probation, not to exceed one year, before 12 appointment or promotion may be made complete and during which period a 13 probationer may be separated from his or her position without the right 14 of appeal or hearing. After a probationer has been separated, he or she 15 may again be placed on the eligible list at the discretion of the county 16 17 personnel officer. The rules and regulations shall provide that a probationer shall be dropped from the payroll at the expiration of his or 18 her probationary period if, within ten days prior thereto, the appointing 19 authority has notified the county personnel officer in writing that the 20 services of the employee have been unsatisfactory; 21

(8) For temporary or seasonal appointments of limited terms of notto exceed one year;

(9) For part-time appointment in which the employee accrues benefits

2 48-1101 It is the policy of this state to foster the employment of all employable persons in the state on the basis of merit regardless of 3 4 their race, color, religion, sex, disability, or national origin, sexual orientation, or gender identity and to safeguard their right to obtain 5 and hold employment without discrimination because of their race, color, 6 religion, sex, disability, or national origin, sexual orientation, or 7 gender identity. Denying equal opportunity for employment because of 8 9 race, color, religion, sex, disability, or national origin, sexual 10 orientation, or gender identity is contrary to the principles of freedom and is a burden on the objectives of the public policy of this state. The 11 policy of this state does not require any person to employ an applicant 12 13 for employment because of his or her race, color, religion, sex, disability, or national origin, sexual orientation, or gender identity, 14 and the policy of this state does not require any employer, employment 15 agency, labor organization, or joint labor-management committee to grant 16 17 preferential treatment to any individual or to any group because of race, color, religion, sex, disability, or national origin, sexual orientation, 18 or gender identity. 19

It is the public policy of this state that all people in Nebraska, 20 both with and without disabilities, shall have the right and opportunity 21 22 to enjoy the benefits of living, working, and recreating within this state. It is the intent of the Legislature that state and local 23 24 governments, Nebraska businesses, Nebraska labor organizations, and 25 Nebraskans with disabilities understand their rights and responsibilities under the law regarding employment discrimination and the prevention of 26 27 discrimination on the basis of disability.
