1 Section 1. Section 38-3301, Reissue Revised Statutes of Nebraska, is

- 3 38-3301 Sections 38-3301 to 38-3335 <u>and section 3 of this act</u>shall
- 4 be known and may be cited as the Veterinary Medicine and Surgery Practice
- 5 Act.
- 6 Sec. 2. Section 38-3302, Reissue Revised Statutes of Nebraska, is

- 12 Sec. 3. Equine massage therapy means the therapeutic application of
- 13 <u>hands-on massage techniques for the purpose of increasing circulation,</u>
- 14 relaxing muscle spasms, relieving tension, enhancing muscle tone, and
- increasing range of motion in high-performance horses.
- 16 Sec. 4. Section 38-3314, Reissue Revised Statutes of Nebraska, is

- 18 38-3314 Unlicensed assistant means an individual who is not a
- 19 licensed veterinarian, a licensed veterinary technician, or a licensed
- 20 animal therapist and who is working in veterinary medicine. <u>Unlicensed</u>
- 21 assistant does not include a person engaged in equine massage therapy.
- 22 Sec. 5. Section 38-3321, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 24 38-3321 No person may practice veterinary medicine and surgery in
- 25 the state who is not a licensed veterinarian, no person may perform
- 26 delegated animal health care tasks in the state who is not a licensed
- 27 veterinary technician or an unlicensed assistant performing such tasks
- 28 within the limits established under subdivision (2) of section 38-3326,
- 29 and no person may perform health care therapy on animals in the state who
- 30 is not a licensed animal therapist. The Veterinary Medicine and Surgery
- 31 Practice Act shall not be construed to prohibit or require licensure

- 1 under the act for:
- 2 (1) An employee of the federal, state, or local government from
- 3 performing his or her official duties;
- 4 (2) A person who is a student in a veterinary school from performing
- 5 duties or actions assigned by his or her instructors or from working
- 6 under the direct supervision of a licensed veterinarian;
- 7 (3) A person who is a student in an approved veterinary technician
- 8 program from performing duties or actions assigned by his or her
- 9 instructors or from working under the direct supervision of a licensed
- 10 veterinarian or a licensed veterinary technician;
- 11 (4) Any merchant or manufacturer from selling feed or feeds whether
- 12 medicated or nonmedicated;
- 13 (5) A veterinarian regularly licensed in another state from
- 14 consulting with a licensed veterinarian in this state;
- 15 (6) Any merchant or manufacturer from selling from his or her
- 16 established place of business medicines, appliances, or other products
- 17 used in the prevention or treatment of animal diseases or any merchant or
- 18 manufacturer's representative from conducting educational meetings to
- 19 explain the use of his or her products or from investigating and advising
- 20 on problems developing from the use of his or her products;
- 21 (7) An owner of livestock or a bona fide farm or ranch employee from
- 22 performing any act of vaccination, surgery, pregnancy testing,
- 23 retrievable transplantation of embryos on bovine, including recovering,
- 24 freezing, and transferring embryos on bovine, or the administration of
- 25 drugs in the treatment of domestic animals under his or her custody or
- 26 ownership nor the exchange of services between persons or bona fide
- 27 employees who are principally farm or ranch operators or employees in the
- 28 performance of these acts;
- 29 (8) A member of the faculty of a veterinary school or veterinary
- 30 science department from performing his or her regular functions, or a
- 31 person lecturing or giving instructions or demonstrations at a veterinary

1 school or veterinary science department or in connection with a

- 2 continuing competency activity;
- 3 (9) Any person from selling or applying any pesticide, insecticide,
- 4 or herbicide;
- 5 (10) Any person from engaging in bona fide scientific research which
- 6 reasonably requires experimentation involving animals;
- 7 (11) Any person from treating or in any manner caring for domestic
- 8 chickens, turkeys, or waterfowl, which are specifically exempted from the
- 9 Veterinary Medicine and Surgery Practice Act;
- 10 (12) Any person from performing dehorning or castrating livestock,
- 11 not to include equidae.
- 12 For purposes of the Veterinary Medicine and Surgery Practice Act,
- 13 castration shall be limited to the removal or destruction of male testes;
- 14 (13) Any person who holds a valid credential in the State of
- 15 Nebraska in a health care profession or occupation regulated under the
- 16 Uniform Credentialing Act from consulting with a licensed veterinarian or
- 17 performing collaborative animal health care tasks on an animal under the
- 18 care of such veterinarian if all such tasks are performed under the
- 19 immediate supervision of such veterinarian;—or
- 20 (14) A person from performing a retrievable transplantation of
- 21 embryos on bovine, including recovering, freezing, and transferring
- 22 embryos on bovine, if the procedure is being performed by a person who
- 23 (a) holds a doctorate degree in animal science with an emphasis in
- 24 reproductive physiology from an accredited college or university and (b)
- 25 has and can show proof of valid professional liability insurance; or -
- 26 (15) Any person engaging solely in equine massage therapy.

- 28 Reissue Revised Statutes of Nebraska, are repealed.
