1 Section 1. Section 37-201, Revised Statutes Cumulative Supplement,

- 3 37-201 Sections 37-201 to 37-811 and 37-1501 to 37-1510 <u>and section</u>
- 4 3 of this act shall be known and may be cited as the Game Law.
- 5 Sec. 2. Section 37-405, Revised Statutes Cumulative Supplement,
- 6 2014, is amended to read:
- 7 37-405 (1) The commission shall provide for the issuance of permits
- 8 to hunt, fish, or harvest fur. Application for such permits shall be made
- 9 to the commission or its agents and shall contain such information as may
- 10 be prescribed by the commission. All applications for permits to harvest
- 11 fur shall include the applicant's social security number. A permit shall
- 12 authorize the person to whom it is issued to hunt, fish, or harvest fur-
- 13 bearing animals as provided by the Game Law during the period for which
- 14 the permit is issued.
- 15 (2) If the holder of a hunting permit is a hunter of migratory game
- 16 birds, he or she shall be required to declare himself or herself as such
- 17 and provide information regarding his or her migratory game bird hunting
- 18 activity to the commission. Documentation of such a declaration shall be
- 19 made on the hunting permit or a separate document which shall become a
- 20 part of the permit. Costs to the commission of implementing such
- 21 declaration and documentation and for participation in a federal program
- 22 designed to obtain survey information on migratory bird hunting activity
- 23 shall be funded from the State Game Fund. For purposes of this
- 24 subsection, migratory bird has the definition found in 50 C.F.R. part 10,
- 25 subpart B, section 10.12, and migratory game bird has the definition
- 26 found in 50 C.F.R. part 20, subpart B, section 20.11(a).
- 27 (3)(a) All permits shall expire at midnight on December 31 in the
- 28 year for which the permit is issued, except as otherwise provided in
- 29 subdivision (b) of this subsection and sections 37-415, 37-420, and
- 30 37-421 and section 3 of this act.
- 31 (b) The commission may issue multiple-year permits to hunt, fish, or

- 2 last year for which the permit is valid.
- 3 (c) A multiple-year permit issued to a resident of Nebraska shall
- 4 not be made invalid by reason of the holder subsequently residing outside
- 5 of Nebraska.
- 6 (4) A person who is hunting, fur harvesting, or fishing shall
- 7 present evidence of having a permit immediately upon demand to any
- 8 officer or person whose duty it is to enforce the Game Law. Any person
- 9 hunting, fishing, or fur harvesting in this state without such evidence
- 10 shall be deemed to be without such permit.
- 11 (5) The commission shall adopt and promulgate rules and regulations
- 12 necessary to carry out this section.
- 13 Sec. 3. (1) Any veteran who is a legal resident of the State of
- 14 Nebraska shall, upon application and payment of a five-dollar fee, be
- 15 <u>issued a combination fishing and hunting permit, habitat stamp, aquatic</u>
- 16 habitat stamp, and Nebraska migratory waterfowl stamp if the veteran:
- 17 <u>(a) Was discharged or separated with a characterization of honorable</u>
- 18 o<u>r general (under honorable conditions); and</u>
- 19 (b) Was a prisoner of war in any war as a result of service in the
- 20 armed forces of the United States.
- 21 (2) All permits issued pursuant to this section shall be perpetual
- 22 and become void only upon termination of eligibility as provided in this
- 23 <u>section.</u>
- 24 (3) The commission may adopt and promulgate rules and regulations
- 25 necessary to carry out this section.
