Committee:

- 1 A BILL FOR AN ACT relating to the Motor Vehicle Certificate of Title Act;
- 2 to amend section 60-154, Revised Statutes Cumulative Supplement,
- 3 2014; to increase original certificate of title fees for vehicles
- 4 transferred to Nebraska from another state; to provide for
- 5 distribution of such fees; and to repeal the original section.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-154, Revised Statutes Cumulative Supplement,
2 2014, is amended to read:

3 60-154 (1)(a) Except as provided in subdivision (1)(b) of this
4 section, for ~~For~~ each original certificate of title issued by a county
5 for a motor vehicle or trailer, the fee shall be ten dollars. Three
6 dollars and twenty-five cents shall be retained by the county. Four
7 dollars shall be remitted to the State Treasurer for credit to the
8 Department of Motor Vehicles Cash Fund. Two dollars shall be remitted to
9 the State Treasurer for credit to the General Fund. Seventy-five cents
10 shall be remitted to the State Treasurer for credit as follows: Twenty
11 cents to the Motor Vehicle Fraud Cash Fund; forty-five cents to the
12 Nebraska State Patrol Cash Fund; and ten cents to the Nebraska Motor
13 Vehicle Industry Licensing Fund.

14 (b) For each original certificate of title issued by a county for a
15 motor vehicle or trailer being titled in Nebraska from another state or
16 country, the fee shall be twenty-five dollars. Twelve dollars and fifty
17 cents shall be retained by the county. Six dollars shall be remitted to
18 the State Treasurer for credit to the Department of Motor Vehicles Cash
19 Fund. Four dollars and fifty cents shall be remitted to the State
20 Treasurer for credit to the General Fund. One dollar shall be remitted to
21 the State Treasurer for credit to the Health and Human Services Cash Fund
22 for use by the Department of Health and Human Services for programs for
23 persons suffering from a brain injury. One dollar shall be remitted to
24 the State Treasurer for credit as follows: Twenty-five cents to the Motor
25 Vehicle Fraud Cash Fund; sixty-five cents to the Nebraska State Patrol
26 Cash Fund; and ten cents to the Nebraska Motor Vehicle Industry Licensing
27 Fund.

28 (2)(a) Except as provided in subdivision (2)(b) of this section, for
29 ~~(b) For~~ each original certificate of title issued by a county for an all-
30 terrain vehicle, a utility-type vehicle, or a minibike, the fee shall be
31 ten dollars. Three dollars and twenty-five cents shall be retained by the

1 county. Four dollars shall be remitted to the State Treasurer for credit
2 to the Department of Motor Vehicles Cash Fund. Two dollars shall be
3 remitted to the State Treasurer for credit to the General Fund. Seventy-
4 five cents shall be remitted to the State Treasurer for credit as
5 follows: Twenty cents to the Motor Vehicle Fraud Cash Fund; and fifty-
6 five cents to the Nebraska State Patrol Cash Fund.

7 (b) For each original certificate of title issued by a county for an
8 all-terrain vehicle, a utility-type vehicle, or a minibike being titled
9 in Nebraska from another state or country, the fee shall be twenty-five
10 dollars. Twelve dollars and fifty cents shall be retained by the county.
11 Six dollars shall be remitted to the State Treasurer for credit to the
12 Department of Motor Vehicles Cash Fund. Four dollars and fifty cents
13 shall be remitted to the State Treasurer for credit to the General Fund.
14 One dollar shall be remitted to the State Treasurer for credit to the
15 Health and Human Services Cash Fund for use by the Department of Health
16 and Human Services for programs for persons suffering from a brain
17 injury. One dollar shall be remitted to the State Treasurer for credit as
18 follows: Twenty-five cents to the Motor Vehicle Fraud Cash Fund; and
19 seventy-five cents to the Nebraska State Patrol Cash Fund.

20 (3)(a) Except as provided in subdivision (3)(b) of this section and
21 in section 60-159.01, for (2) For each original certificate of title
22 issued by the Department of Motor Vehicles department for a vehicle
23 except as provided in section 60-159.01, the fee shall be ten dollars.
24 Four dollars shall be remitted to the State Treasurer for credit to the
25 Department of Motor Vehicles Cash Fund. Six dollars shall be remitted to
26 the State Treasurer for credit to the Motor Carrier Division Cash Fund.

27 (b) For each original certificate of title issued by the department
28 for a vehicle titled in Nebraska from another state or country, the fee
29 shall be twenty-five dollars. Ten dollars shall be remitted to the State
30 Treasurer for credit to the Department of Motor Vehicles Cash Fund.
31 Fourteen dollars shall be remitted to the State Treasurer for credit to

1 the Motor Carrier Division Cash Fund. One dollar shall be remitted to the
2 State Treasurer for credit to the Health and Human Services Cash Fund for
3 use by the Department of Health and Human Services for programs for
4 persons suffering from a brain injury.
