FOR AN ACT relating to the Behavioral Health Education Center; to
amend section 71-830, Revised Statutes Cumulative
Supplement, 2012; to provide for psychology internships
as prescribed; and to repeal the original section.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-830, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 71-830 (1) The Behavioral Health Education Center is
- 4 created beginning July 1, 2009, and shall be administered by the
- 5 University of Nebraska Medical Center.
- 6 (2) The center shall:
- 7 (a)(i) Provide funds for two additional medical residents
- 8 in a Nebraska-based psychiatry program each year starting in 2010
- 9 until a total of eight additional psychiatry residents are added in
- 10 2013. Beginning in 2011 and every year thereafter, the The center
- 11 shall provide psychiatric residency training experiences that serve
- 12 rural Nebraska and other underserved areas. As part of his or her
- 13 residency training experiences, each center-funded resident shall
- 14 participate in the rural training for a minimum of one year.
- 15 Beginning in 2012, a A minimum of two of the eight center-funded
- 16 residents shall be active in the rural training each year; and
- 17 <u>(ii) Provide funds for five one-year doctoral-level</u>
- 18 psychology internships in Nebraska within twelve months after the
- 19 effective date of this act and every year thereafter and increase the
- 20 number of interns in the program to ten within thirty-six months
- 21 after the effective date of this act. The interns shall be placed in
- 22 communities so as to increase access to behavioral health services
- 23 for patients residing in rural and underserved areas of Nebraska.
- 24 (b) Focus on the training of behavioral health
- 25 professionals in telehealth techniques, including taking advantage of

1 a telehealth network that exists, and other innovative means of care

- 2 delivery in order to increase access to behavioral health services
- 3 for all Nebraskans;
- 4 (c) Analyze the geographic and demographic availability
- 5 of Nebraska behavioral health professionals, including psychiatrists,
- 6 social workers, community rehabilitation workers, psychologists,
- 7 substance abuse counselors, licensed mental health practitioners,
- 8 behavioral analysts, peer support providers, primary care physicians,
- 9 nurses, nurse practitioners, and pharmacists;
- 10 (d) Prioritize the need for additional professionals by
- 11 type and location;
- 12 (e) Establish learning collaborative partnerships with
- 13 other higher education institutions in the state, hospitals, law
- 14 enforcement, community-based agencies, and consumers and their
- 15 families in order to develop evidence-based, recovery-focused,
- 16 interdisciplinary curriculum curricula and training for behavioral
- 17 health professionals delivering behavioral health services in
- 18 community-based agencies, hospitals, and law enforcement. Development
- 19 and dissemination of such curriculum curricula and training shall
- 20 address the identified priority needs for behavioral health
- 21 professionals; and
- 22 (f) Beginning in 2011, develop two interdisciplinary
- 23 behavioral health training sites each year until a total of six sites
- 24 have been developed. Four of the six sites shall be in counties with
- 25 a population of fewer than fifty thousand inhabitants. Each site

1 shall provide annual interdisciplinary training opportunities for a

- 2 minimum of three behavioral health professionals.
- 3 (3) No later than December 1, 2011, and no later than
- 4 December 1 of every odd-numbered year, thereafter, the center shall
- 5 prepare a report of its activities under the Behavioral Health
- 6 Workforce Act. The report shall be filed electronically with the
- 7 Clerk of the Legislature and shall be provided electronically to any
- 8 member of the Legislature upon request.
