1 Section 1. Section 81-1407, Reissue Revised Statutes of Nebraska, is

3 81-1407 (1) The Nebraska Police Standards Advisory Council shall 4 consist of seven members until January 1, 2017, and nine members 5 beginning January 1, 2017, appointed by the Governor. Six of the members

shall be full-time officers or employees of a law enforcement agency and 6 7

shall include one representative chief of police or his or her designee

from a city of the metropolitan or primary class, a representative chief 8

of police or his or her designee from a city of the first class, a

representative chief of police or his or her designee from a city of the

second class or village, a county sheriff or his or her designee from a

county having a population of forty thousand or more, a county sheriff or

his or her designee from a county having a population of forty thousand

or less, and a member of the Nebraska State Patrol. The seventh member of

the council shall be a member of the Jail Standards Board or a person

from the public at large. The representative chief of police or his or

17 her designee from a city of the metropolitan or primary class shall not

be a regular member of the commission. The eighth and ninth members of 18

the council shall be full-time officers of a law enforcement agency of 19

this state with a rank of sergeant or below. 20

(2) The members of the council shall serve for terms of four years 21 each. Of the members first appointed, one shall serve for a term of one 22 year, one shall serve for a term of two years, one shall serve for a term 23 24 of three years, and two shall serve for terms of four years from January 1 next succeeding their appointment. Within ninety days after July 16, 25 1994, the Governor shall appoint the two additional members who shall 26 27 serve for terms of four years from January 1 next succeeding their 28 appointment. The Governor shall appoint the eight and ninth members of the council to begin serving on January 1, 2017. A member may be 29 reappointed at the expiration of his or her term. Any vacancy occurring 30 otherwise than by expiration of a term shall be filled, for the remainder 31

- 1 of the unexpired term, in the same manner as the original appointment.
- 2 The council shall select one of its members as chairperson.
- 3 (3) No member of the council shall serve beyond the time when he or
- 4 she holds the office or employment by reason of which he or she was
- 5 initially eligible for appointment. A member may be removed from the
- 6 council for cause upon notice and an opportunity to be heard at a public
- 7 hearing before the Governor. After the hearing, the Governor shall file
- 8 in the office of the Secretary of State a complete statement of the
- 9 charges, his or her findings and disposition, together with a complete
- 10 record of the proceedings.
